PROPOSED TEMPORARY TURBIDITY INCREASE IN OWL CREEK IN HOT SPRINGS COUNTY

Gerber Construction, Inc. has requested a waiver from the Wyoming Department of Environmental Quality Water Quality Division (WDEQ/WQD) for a temporary increase in turbidity in Owl Creek (Section 8, T43N, R94W) in Hot Springs County. Activity in Owl Creek is normally limited to a ten NTU increase over background. Approval of this request would allow an exceedance of this limit for up to 2 work days, subject to monitoring and reporting. This activity will follow the procedures in Chapter 1, Section 23(c)(ii), of the WDEQ Water Quality Rules and Regulations, which allow for temporary elevated levels of turbidity in certain circumstances. Proposed activity includes pier cap repair on the bridge.
