The Hot Springs County Board of Commissioners met in regular session on Tuesday, March 5, 2019 at 9:00 a.m. in the Public Meeting Room at the Government Annex. Present were Commissioners Tom Ryan, Jack Baird and Phillip Scheel. Also present were County Attorney Jill Logan, Chief Deputy Clerk Karen Slocum and Administrative Assistant to the Commissioners Penny Herdt. Chairman Ryan led those present in the Pledge of Allegiance.

Approval of Agenda – The Agenda was approved with the addition of Correspondence – Item 4 – High Plains Power Proxy.

Approval of Minutes – The minutes from February 5 and 19, 2019 were approved as presented.

4-H Educator Expense Account Discussion – After reviewing his denied mileage submission from February with 4-H Extension Educator Joey Johnson, the Commissioners agreed to pay it.

FBO Monthly Report – There were 86 total recorded operations in February. AvGas sales were 524 gallons and Jet Fuel sales totaled 144 gallons. There were two corporate aircraft that cancelled due to a lack of transient hangar space.

Road & Bridge Monthly Report – The replacement HRRR signs have been received and installed. New signage for Gooseberry Bridge is on the way and will be installed when it is received. All wooden bridges are getting new signs due to a change in WYDOT policy. In discussing Black Mountain Road rights of way, it was determined that the bridges belong to the County, but the ROW belongs to WYDOT for the first 3.3 miles of the road. WYDOT is in the process of turning that ROW over to the County, at which time the County will work with the BLM to obtain a perpetual ROW and maintenance agreement.

Guardrail Project – The Commissioners approved the contract agreement and contract book covers for the FY-17 High Risk Rural Roads Project HR 17504 with S&L Industrial.

Youth Alternatives Monthly Report – There are currently twenty two participants in the diversion program, and two youths being worked with at the elementary school. Oversight is being provided for two adult probationers. Since October there have been seven students who have left school for various reasons including expulsion. Youth Alternatives is currently facilitating a youth alternative educational program for these students in an attempt to keep them motivated and engaged in the learning process so they can eventually return to school. A 10:00 p.m. curfew for program participants has been instituted and seems to be working well.

VOA Grant Funding – The VOA is nearly two years behind in grant reimbursements and is now asking for resubmission of information from two years ago before they provide the awarded funds. The Commissioners requested the Youth Alternatives Director to provide a complete report on the status of the VOA reimbursements at the March 19th meeting. The Commissioners formally decided not to apply for the VOA funding cycle in July.

Emergency Management Monthly Report – The following trainings are being coordinated through the Emergency Management office: Annual Flood Summit on March 19th in Riverton, Hot Springs County COAD Initiative presented by Cindy Schenk in Thermopolis on March 22nd, Court Security Committee meeting on March 22 at 8:00 a.m., American Red Cross Psychological First Aid in Thermopolis on April 5th, and FEMA's Business Continuity Planning for Emergencies in Thermopolis on June 12th. Future trainings will include a focus on extended, long-term power outages.

Maintenance Monthly Report – All issues raised in the annual fire code inspection conducted in December have been addressed. The sprinkler system inspections for the Museum and the Detention Center will be conducted next week. The basement floor repair is underway. Concrete will be poured in the next couple of weeks in preparation for installation of a two-part epoxy floor.

Public Health/Prevention Monthly Report No applications have been received for the Maternal/Child Health Nurse position posted in February. There have been thirteen Long Term Care referrals in the last two weeks. Monthly foot clinics continue. The Hot Springs County Public Health is one of only two public health departments in the state that offer these clinics. Income is up about 16% for this fiscal year. Immunization expenses continue to increase. Public Health is currently providing strep tests for the hospital and Red Rock Family Practice. Prevention – The Commissioners approved the hiring of Jennifer Cheney for the position of Prevention Specialist. The school district has requested a Memorandum of Understanding with the County outlining the District's and the County's duties and responsibilities for the Prevention Specialist position. This MOU is being drafted with the County Attorney for consideration at the March 19th meeting. The Coalition has completed the Community Assessment and submitted it to the State for consideration. The County now has ninety days to complete the work plan for the grant. The Commissioners will meet with the Prevention Coordinator for a grant funds distribution work session at 2:00 p.m on March 19th.

Joint Law Enforcement Center Discussion – The Commissioners took under consideration a proposal from the Town regarding the JLEC wherein the Town would provide dispatch services to the County in return for having no other obligation with regard to the JLEC except sharing in the maintenance, repair, replacement and supplies for the equipment located in Dispatch. Sheriff Jerimie Kraushaar and TCI representative Dean Peranteaux offered their input on the Town's proposal. Sheriff Kraushaar was asked to gather cost data regarding switching from Spillman to RIMS for the report writing and retention program. Mr. Peranteaux is meeting with the Town Council tonight to discuss their involvement in the IT process. He would like to see two agreements – one concerning the JLEC/Dispatch and the other concerning IT support for the County and Town law enforcement. Town representatives Fred Crosby and Mike Messenger joined the meeting to provide input on the discussion from the Town's point of view. Mr. Messenger will work on drafting agreements/MOU's for Dispatch and IT services for review at the April 2nd meeting.

Census Update Census Coordinator Judy Carswell provided the Commissioners with a list of the Complete Count Committee members and a memo regarding the organizational meeting of the CCC committee held in February.

Airport Pavement Maintenance Project T-O representative Jeremy Gilb reviewed the

status of Pavement Maintenance Project #AIP-03-56-0043-011-2019. This project cost is split 90% FAA, 6% WYDOT, and 4% County, with an estimated total cost of \$333,333.00. The FAA has released new specifications regarding paint removal that may significantly impact this project. T-O has submitted a potential solution to the paint removal problem to the FAA for approval. The scope of work presented to the Commissioners today is based on that solution. If the solution is not approved and complete paint removal is required, DBE requirements will come into effect, which will increase the project costs significantly. The current plan is to complete the Sealcoat and Marking project in the July-August timeframe, depending on coordination with the airport FBO.

Other Business

Consider SLIB Re-Allocation Application - Phillip Scheel moved to sign the application to the SLIB board to reallocate unused funds from previous Consensus projects to the Fairgrounds Repair and Improvement projects in the amount of \$32,058.00. Jack Baird seconded the motion. Motion carried.

Appoint Predator Board Member (Sportsman) - Jack Baird moved to appoint Mark Phipps to one of the openings on the Predatory Animal Control Board. Phillip Scheel seconded the motion. Motion carried.

Snow Fence License Review – County Attorney Jill Logan will work with Road & Bridge Supervisor Dave Schlager to make corrections to the license agreement and return it for the Commissioners' signature.

BHBND C Musser Grant Application Support Letter - Phillip Scheel moved to sign a letter of support for the Big Horn Basin Nature and Discovery Center's Children's Discovery Area grant application to the Laura Jane Musser Foundation. Jack Baird seconded the motion. Motion carried
