HSCHS seniors bid adieu during commencement

Forty-two seniors walked across the stage to receive their diplomas as the Class of 2010 during the 90th Hot Springs County High School Commencement Exercise on Sunday in the HSCHS gym.

Six of the graduates departed as members of the National Honor Society – valedictorian Cody Abbott, salutatorian Colin Herold, class president Kylie Olsen, Baylee Dickinson, Sharena Hessenthaler and Weston Hubele.

Fifteen of the seniors left HSCHS with a GPA of 3.5 or higher.

The Class of 2010 chose not one, but two guest speakers. The first was teacher Aimee Kay, who went hand-in-hand with students during their four years of high school in Thermopolis.

During her address, Kay brought back a bevy of memories she shared with the graduating seniors.

Her tears of joy and a bittersweet goodbye were heartfelt as she spoke of many of the highlights over four years.

Todd and Barb Rice were also chosen by the class as guest speakers, and Barb addressed the graduates with words of encouragement and a fond fare-

It was an emotional time for Todd and Barb Rice. They lost their son Bud to a fatal illness in the summer of June 2005 when he was a student at Thermopolis Middle School.

This would have been his graduating class, and everyone who know Todd and Barb consider Bud as part of the Class of 2010, yet today.

As the top two students in the class, academically, Abbott and Herold delivered meaningful valedictory and salutatory addresses, respectively, that were absorbed by all the other 40 graduates.

Olsen introduced the speakers and also addressed the other graduates.

The HSCHS/Thermopolis Middle School band played "Pomp & Circumstance" and the recessional to open and close Sunday's ceremony.

The HSCHS choir sang the National Anthem and Omnia Sol, and senior choir members performed "Hallelujah."

Special music was provided by graduate Riley Sikes, who sang and played "Nice to Know You," an original composition on his guitar.

While incoming class president Bridger Lewis read the list of graduates, Elizabeth Mahoney, chair of the Hot Springs County Board of Education, presented the diplomas.

The senior class advisors were Bryan Bailey, Kent Hessenthaler, Matt Mason, Brenda Peterman and Kathie Richardson.

The class motto was "Ride the Dream." The flower was the yellow snap dragon and the class song was "Ramble On" by Led Zeppelin.

Seven incumbents have registered to run for office again in

Hot Springs County. Sheriff Lou Falgoust, County Clerk Hans Odde, Treasurer Mickeyjean Ford, Assessor Shelley Deromedi, Clerk of District Court Terri Cornella, County Attorney Jerry Williams and Coroner Mike Mortimore have all filed the necessary paperwork to be included on the primary ballot Aug. 17.

All of the candidates registered so far come from the Republican Party.

The only office being contested at this time is the office of county attorney. Incumbent Jerry Williams will be challenged by attorney Sandra Baker.

Two positions for county commissioner are also open for election, and incumbent chairman John Lumley and newly appointed commissioner Mike Baker have both registered with the county clerk's office.

The general election will be held on Nov. 2.
