Overpayment of severance tax a surprise

A lot of questions are still unanswered in regards to the State of yoming's request for repayment of severance taxes from 1995.

The state treasurer's office overpaid severance taxes to towns, cities and counties that year in an estimated amount of \$3.65 million. Now, the state wants its money back.

The Hot Springs County Commissioners were made aware of the situation the last week in June; however, according to assistant to the mayor Dan Stansill, the Town of Thermopolis was not aware of the repayment schedule until reading about it in the Thermopolis Independent Record.

Stansill said there were discussions about the repayment a couple of years ago and the town had actually budgeted an amount they thought they would have to repay.

"The municipalities thought it was going to be dropped," Stansill said. "We haven't received anything from the state.

"We're not real happy about it."

Stansill said the money that had been set aside has now been spent since the Wyoming Association of Municipalities had told its members the state was not going to pursue repayment.

"This was brought to the Appropriations Committee sometime in 2009," State Rep. Lorraine Quarberg said, a full 15 years after the millions had been distributed.

Quarberg said she has been in contact with State Treasurer Joe Meyer regarding the situation since finding out about it last

"I told him the towns and counties had already set their budgets for the year," she said. "I'm concerned that we're all in shortfall status as it is.

"He (Meyer) assured me he will continue to make calls and look into the options," Quarberg said. "The information I have received indicates the state wanted to start repayment July first. I would prefer they don't put the schedule into effect until 2011."

Quarberg asked Meyer if there would be any legal ramificalooking into it.

"Actually, the state doesn't even have a firm dollar amount," Quarberg said.

Quarberg believes there is a definite lack of communication be-

tween the associations and their membership. "The Town of Thermopolis and the county commissioners did not understand this repayment was going to start in 2010," she said. "Everybody needs to know the payback terms. It needs to be spelled out completely.'

State Sen. Gerald Geis said he was unaware of the situation since it had come from the Appropriations Committee.

"If it happened 15 years ago, they should let bygones be bygones," he said. "Now is not the time to be asking for money back."
