# Fire lane system could see change

Few residents of rural Hot Springs County attended a meeting regarding fire number changes in the county at Thermopolis Middle School Tuesday night.

Those in attendance found out the current numbering system for rural fire numbers, also used as home addresses for residents, is about to undergo a complete revamping at the direction of the Wyoming Department of Transportation (WYDOT).

Fire numbers will have to be moved from WYDOT's right-ofway along the road to the property edge. With the tremendous amount of growth in homes and subdivisions in the county, many of those numbers are going to be changed and some roads renamed.

"These numbers have been in place since the 1970s," road and bridge supervisor Ray Shaffer said. "Many of them are gone or dilapidated to the point they're unreadable.

"The problem is, with all the growth we've had there isn't room for new fire numbers to be placed in a lot of areas so a new plan has to be developed to allow for new numbers to be put in."

The fire numbers were put in place originally based on the distance from the stoplight in the center of town to the rural residence.

The numbers are used for mail delivery as well as for emergency responders to find a home.

"The only way to find you is by rural fire number," said Mark Mortimore of Mortimore Ambulance Service. "Without those, we can't find you, it's that simple.

"If we don't see them we just keep driving until we find one. Once we're off the marked pavement, we're basically lost without those numbers.

"I've lived here all my life and there are still places I don't even know where they are. The age of GPS (global positioning service) is great if you're a helicopter, but we don't fly," Mortimore said.

#### Federal mandate for sign update

Shaffer said there was a Federal mandate that all signage needs to be updated to a prismatic, highly reflective sign

"We're going to have to replace what's out there anyway and it's going to be expensive,' he said. "It's not something we

## BLM goes forth with RMP despite Salazar's request to take no action

In spite of a decision by Interior Secretary Ken Salazar directing the Bureau of Land Management (BLM) to take no action under the Wild Lands Order, the BLM held a public meeting Monday night at Days Inn to discuss their draft Resource Management Plan (RMP).

Wyoming Gov. Matt Mead has opposed the order from the beginning, speaking about it on several occasions.

"The decision to reverse course on the Wild Lands Order is in the best interest of Wyoming and the entire West," Mead said. "I have already thanked Secretary Salazar for listening to the people of Wyoming.

My office worked closely with our county commissioners, our business owners and our Congressional delegation to let the secretary know that this order would have had serious effects on Wvoming's economy, which depends on the multiple use of public lands."

BLM personnel outweighed the number of local residents for the three-hour public meeting, enabling them to discuss the maps on display on a more one-on-one basis.

Each of the different maps on display featured the four proposals the BLM have developed, ranging from allowing the current management to remain in place, to the tightest restrictions seen in the four-county area — Hot Springs, Park, Big Horn and Washakie counties.

At a recent public meeting held by the county commissioners and the conservation district, concerns were raised by local oil interests that areas the BLM plans to manage would cut off their access to their fields and possibly eliminate future production and drilling.

According to the BLM's Sarah Beckwith, their plan is to manage the areas to protect the development of oil and gas within the

"Other things were starting to encroach on the areas," Beckwith said. "We want to make sure those encroachments are minimized."

Beckwith said the proposed changes in their preferred Plan D would not prevent future production or drilling for oil or gas in the managed areas.

Of significant importance to the tourism aspect of Hot Springs

County is the geothermal properties of the Big Spring and surrounding waters.

For years it has been the policy of the commissioners and county planner to have a geological study done before allowing the drilling of domestic or stock water wells near the springs. Without the approval of a geologist, no drilling can occur in certain areas.

Beckwith said protection of the geothermal properties in Hot prings County is of tantamount importance to the RLM and they have enlarged the protected area around the springs to ensure development of the area will not hurt the water flow.

We have noticed some change in the amount of water going through the springs as well as a slight shifting of where the water is flowing," she said. "By adjusting the protected area around the springs, we can take those shifts into consideration."

Wildlife protection areas, especially those for sage grouse, play a big part in the land management for the four counties as well.

# Power outage extends 27 hours

About 500 High Plains Power rural customers in northern Hot Springs County were without electricity for nearly 27 hours when a bushing on a transformer near Lucerne blew out mid-afternoon Wednesday, June 1.

Power was lost about 4:30 p.m. and was resumed around 7:30 p.m. Thursday, according to Oswald Smith, High Plains Power office manager in Riverton.

"We had to get a Tri-State (Generation

and Transmission) mobile transformerin," Smith said, the unit coming from Greybull.

However, the semi hauling the heavy unit became stuck in mud on Sprowl Road, which leads onto Dr. Howard Willson's property. Once the truck began moving again, the repairs were under way.

"The operations manager said it was going to be tomorrow sometime," Smith said of the resumption of power to High Plains customers, knowing it would be at

He said the transformer was built around the mid-1980s and High Plains would not know the extent of the damage to the transformer until it's thoroughly checked out. If a new transformer is required, Smith said it could take from three to sixth months to have one manufactured.

In the meantime, the mobile transformer is providing power to customers in the area.

# Wyo-Ben proposes new mining project

The Bureau of Land Management (BLM) Worland Field Office announces the availability of an environmental assessment (EA) for a proposed bentonite mining project in Hot Springs

Wyo-Ben, Inc., proposes to conduct new bentonite mining and concurrent reclamation on public land in the Rattlesnake Gulch area east of Thermopolis. Wyo-Ben has been mining in the area since the 1970s and proposes to develop on a maximum of 73 acres. The cast-back mining operation will occur on 10 to 15 acres per year for a proposed seven to 10 years.

The EA has been prepared

to analyze the impacts of the proposed project. It is available for public review and comment by visiting the BLM website at www.blm.gov/wy/st/en/info/ NEPA/documents/wfo/wyo-benprojects.html.

### River rises; runoff won't cause many problems

The flood outlook seems to have diminished over the past few weeks as spring runoff season in Hot Springs County gets closer to its end.


Hot Springs County Emergency Management Coordinator Bill Gordon says the current flow of the Big Horn River was running Tuesday at a rate of 2,400 cubic feet per second

(cfs) with discharges from Boysen Reservoir of 5,400 cfs.

The reservoir is currently 58 percent of capacity, down from 84 percent earlier in the spring. Fremont County is expecting to see record inflows from the Wind River Range that could top 20,000 cfs.

With the amount of space

want to do, but something we have to do.

County residents who were at the meeting expressed concern with changing addresses, pointing out those who have businesses in the country are going to face a good amount of expense if their address changes.

Residents first found out their addresses were being changed when they received a letter in the mail. Some had already been experiencing mail being returned as undeliverable.

"I understand it's frustrating," commissioner Mike Baker said. "You haven't moved an inch and you're going to have to completely change your numbers.

"We commissioners were unaware things had gone this far until notification came from the post office. Our plan was to have this meeting first to get everyone's input.'

The group discussed the possibility of grandfathering the current addresses and coming up with a plan that would allow for future number expansion.

Shaffer presented a plan used by Park County for everyone to review, and the commissioners will be going over it as well, making changes they think would be more appropriate for Hot Springs County.

available in the reservoir and the ability to raise discharges at the dam to 12,000 cfs, it should allow runoff season to pass without problems downstream in Hot Springs County, Gordon said.

Creeks coming from the west may fluctuate daily due to snow pack on high peaks, but according to data created by the National Resource and Conservation Service there is not any

snow at 9,000 feet in the Owl Creek Range. While there is expected to be significant runoff from drainages further west, it will not be nearly as much as some other counties will endure, Gordon said.

The creek also may jam up near Highway 20 North as it tries to enter the river during high flows, he added.

Drainages from the east should have most of the snow-

melt finished. The greatest effects of the streams will be the possibility of flash flooding after downpours in the upper country.

"My summary would be that HSC residents should be vigilant for and during rising water conditions," Gordon said. "But they can also be optimistic that our county will get through the remainder of the runoff season in pretty good shape.'

Hot Springs County already has an effective land use plan in place that takes the natural habitat of wildlife and sage grouse in particular into account. Landowners and the conservation district have worked hand in hand to ensure those habitats are protected.

When asked how the BLM's plan for wildlife protection would make Hot Springs County's plan better, Beckwith had no answer, but agreed the county has an excellent plan in place.

At their regularly scheduled meeting on Tuesday, the commissioners, along with commissioners from the other three counties being affected, cooperatively signed a letter to the BLM requesting an extension of the current comment period on the RMP from 90 days to 120 days.
