Chamber forum platform for community support

Various event organizers and community members attended the Thermopolis-Hot Springs Chamber of Commerce Public Forum Tuesday night at the Hot Springs County Museum and Cultural Center.

Executive Director Michelle Lue opened the forum with an introduction of the chamber's board of directors and a brief synopsis of the chamber's annual activities and statistics

The goal behind the forum was to drum up support for various chamber and community events. The chamber discussed briefly some of its major events, which include the Chamber Banquet March 24, the 3-on-3 Basketball Tournament in May and the Demolition Derby in August, and the significance the events play in running the chamber.

Other presenters included Toddi Darlington and Jacky Wright of the Greater Learning Foundation, Barb Vietti for the Gift of the Waters Pageant, Jane Norskog for the Hot Springs County Community Outreach Coalition, Cassie Norskog for the Thermopolis Recycling Coalition, Tawna McQueen for the Hot Spot Car Rally, Ed Capen for the monthly Acoustic Jam Sessions and Barb Rice regarding volunteerism.

After the presentations, the chamber opened up for questions, which mainly focused on the chamber's dues structure with regard to financial institutions.

Currently, financial institutions have flat dues of \$750 while many other businesses' dues are based on the number of employees and are less than \$750.

Lue said after the forum that the chamber board would discuss the dues structure further during its annual retreat and March board meeting scheduled for 1 p.m. Saturday.

Greater Learning Foundation

Darlington gave a brief overview on the initiative of the foundation to build the Big Horn Basin Nature and Discovery Center at Hot Springs State Park.

The center currently has the support of the Wyoming Office of Tourism, the Department of State Parks and Cultural Resources, Gov. Matt Mead and former Gov. Dave Freudenthal, Darlington said.

The foundation also is in the process of collecting community support to bring a statewide folk life festival to Thermopolis. It is currently collecting support for various needs for the festival from other groups and organizations in the community, Darlington said.

Wright gave a brief presentation on the programs and cultural residencies the foundation has sponsored in the past year, which have included musical programs and classroom workshops performed by various artists such as Bryan Ragsdale, Buffalo Bill Boycott and most recently Men

She encouraged those in attendance to continue to show support for the program by attending the various public performances, which help pay the artists' and musicians' fees for their residency.

Gift of the Waters Pageant

Vietti's presentation discussed the work and need for community support with regard to the fundraising, publicity and production of the Gift of the Waters Pageant.

The committee is currently working toward maintaining and garnering community support in the form of volunteers, financial donations and involvement in order to keep the tradition alive in Thermopolis.

Vietti stressed the importance of the tradition, which has been unique to Thermopolis since 1950 or longer.

The yearlong process of planning for the pageant starts with fundraising in order to account for the cost of the performers, stage, costumes and publicity expenses having to do with the pageant, which does not include the chamber's pageant parade and the Kiwanis Craft Fair.

"We need people to support it financially and also people with knowledge of the pageant," Vietti said. "It is part of Thermopolis!"

Budget bill includes AML funds for UW buildings

As the 61st Wyoming Legislature Budget Session heads down the home stretch, the House and Senate have worked out their differences in the budget bill in conference committee and it was bound for Gov. Matt Mead's desk for his signature.

The budget session is expected to conclude either today (Thursday) or Friday at the state capitol in Cheyenne, according to Rep. Lorraine Quarberg (R-Thermopolis, HD28).

Neither the House nor the Senate included money for overall state employee pay raises in their budget bills, but there were still separate bills that would limit retirement benefits for future state employees and prohibit cost of living increases for current retirees.

A stumbling block between the House and Senate concerning funding of capital construction on the University of Wyoming campus was overcome. The funding pertains to the College of Engineering and Performing Arts buildings. The 100-year-old engineering building renovation is approximately a \$100 million project and the legislature has set aside \$30 million from abandoned mine land (AML) funds to get it started.

Quarberg to not seek re-election

Rep. Lorraine Quarberg (R-Thermopolis) announced Tuesday she will not be running for re-election to House District 28.

"My decision not to seek re-election was made well over a year ago. I want to spend more time with family and friends," Quarberg said.

Quarberg's service in the Wyoming State Legislature began in 2005. During the past eight years, she has served on various committees including Education; Minerals, Business and Economic Development; Corporations, Elections and Political Subdivisions; Judiciary; and Select Water.

Currently, she serves as House Chairman of Transportation, Highways and Military Affairs and continues to serve on Select Water, an appointment she has held since 2005.

"It has been an honor and a privilege to serve the people of Hot Springs County and south Big Horn County," Quarberg said.

Agreement reached on airport land

After months of negotiations, the Hot Springs County Commissioners have apparently reached an agreement with landowner Joe Holden for the purchase of his property west of Thermopolis for the future home of a new county airport.

 $The \, commissioners \, came \, out \,$ of executive session at their meeting Tuesday afternoon and voted to accept a counter offer developed by Holden and his attorney.

While none of the details of the counter offer were available, a caveat with the commissioners' vote states Holden must sign the contract for the purchase by Friday, March 9 or the commissioners will seek further legal action.

At this time the contract signing is scheduled for 3 p.m. in the commissioners' chambers in the Hot Springs County Annex Building.

anyway," Quarberg said. Funding will also be available for renovation of the 40-year-old

Performing Arts building.

Quarberg said the House held its position for approving \$30 million to go to Wyoming highways, using AML funds.

"Energy resource development takes a toll on our roads," she said. Also pertaining to the new budget, state agencies must prepare for 3 percent budget cuts when the legislature convenes in 2013 due to falling natural gas prices.

As of Tuesday, there were 54 "enrolled" bills to be sent to Mead's desk for his endorsement. Wednesday was the last day for third reading on bills in the second house and the deadline for concurrence on amendments and Joint Conference Committee reports was today (Thursday).

Sampling at distilleries

Mead signed SF45, alcoholic beverages-manufacturers, on Wednesday afternoon. That bill allows sampling at distilleries such as Wyoming Whiskey of Kirby.

"It will help make Hot Springs County a destination point," Quarberg said. "It will be a lot of interest to people across the United States and in other countries, too."

Steve and Donna Nally of Wyoming Whiskey were on hand for the signing of the legislation and Quarberg calls them "good business people and wonderful ambassadors."

SF105, school capital construction, became an enrolled bill. It will benefit a number of large and small school districts in Wyoming, including schools in Fremont County, according to Quarberg.

HB88, pertaining to DUI penalties, was also bound for the governor's desk after support from Quarberg. The bill allows a judge to levy a higher maximum sentence to offenders who have at least four DUI (driving under the influence) convictions on his or her record. Quarberg expected HB21, exceeding speed limit while passing,

to become law. Drivers would be allowed to exceed the speed limit by up to 10 mph on an open highway in order to pass a vehicle traveling under the posted speed limit.

HB90, baseline scientific assessments, was also expected to go to the governor. It would put the State of Wyoming "in the driver's seat" when dealing with the Federal government on such issues as resource management plans (RMPs).

Two pieces of legislation pertaining to the media that originated in the Senate should also go to Mead for his signature – SF25, public records, and SF27, public meetings. Quarberg said SF27 would clarify executive committee meetings. "Public meetings are very important. It's something everyone needs to know," she said.

SF41, wolf management, went to Mead's desk. Quarberg did not support the bill. "It's like dealing with a moving target," she said. "It seems like we're consistently giving up more and more control in trying to get them (wolves) de-listed. I'm tired of them (the Federal government) not keeping their word."

Senate's 'whiskey bill' signed by Mead

The 2012 Wyoming Legislative Budget Session appears to be heading for adjournment on time, sometime tomorrow (Friday).

Sen. Gerald Geis (R-Worland, SD20) said things have been going through quickly and smoothly. The redistricting bill went through three quick readings on the Senate side as they accepted the work that was done on the House side. The bill was signed by Gov. Matt Mead on Monday.

Also signed by the governor was the "whiskey bill," Senate File 45 that Geis sponsored,

that would allow distilleries such as Wyoming Whiskey in Kirby to distribute samples of the distilled spirits.

Senate File 105 on School Capital Construction was approved and signed by the governor. In other action, the Senate:

· Approved on second reading is HB 21, allowing drivers to go 10 mph over the speed limit when safely passing a vehicle that is going less than the maximum speed limit allowed. Geis said he does not favor the bill, nor did he favor the 80 mph speed limit proposed on some Wyoming highways, mainly due to safety issues. HB48 on the 80 mph

limit died in committee. ·Approved HB87 on second reading Mon-

day regarding establishing regulations for mixed martial arts. · Approved HB92 on second reading Mon-

day that would add joint powers boards as another entity that can participate in the emergency telephone services program.

· Did not consider House Resolution 10 on rural long distance phone service. Geis said the resolution was asking for Congressional help on third party "least cost routers," such as Magic Jack, whose quality is not good in
