Commissioners upset about Trane project

Hot Springs County Commissioner Mike Baker had no problems Tuesday expressing his displeasure with the managing contractor for Trane regarding the lack of heat on the first and second floor of the county courthouse.

Initially, the heat pump installation for the courthouse was supposed to happen in a couple of months when the weather got warmer; however, for unknown reasons, the schedule was moved up.

"This is not what was supposed to happen," Baker said. "Our maintanance supervisor is having to be pulled off his duties to take care of this. What are you going to do about heat in the building right now?"

The contractor said there was no immediate plan of action, but one solution could be finding mobile heating units to bring into the building until the situation was corrected.

Baker also questioned why the manager had not been on site since April 2.

"I want to start action to protect this county from people who do not keep their word," Baker said. "You haven't appeared for a full week. Someone should be supervising this project and if you're not here, I don't think we should be paying anything to Trane.

"Temperatures here are in the 30s. This is absolutely improper."

County Attorney Jerry Williams added that he recalls a section of the original contract with Trane that stated normal temperatures would be maintained during construction.

This is apparently not the only issue with Trane,

A furnace ordered for the Hot Springs Counseling Center was found to be the wrong type when it was

delivered and had to be exchanged. In addition, the heater for the clerk's office is the wrong size and will have to be replaced as well.

On the lighter side, the project to replace or upgrade lighting in the various buildings is on schedule with crews expected to arrive on Monday.

Trane said the crews would be working 12 or more hours each day to get the lighting project completed as soon as possible.

Lane 3 project update

With the completion of the project on Lane 3, the time has arrived for the county to dispose of a plot of land it purchased in order to have the room to widen the entrance to the road for semi-trucks and other oversized traffic.

Williams suggested the commissioners have a market analysis done by two separate entities and then put the plot up for auction to the public.

"I really don't care how it's done," Williams said, "but I would like to see a set price that will have to be met before the land is transferred."

Currently, there are some items on the property that belong to Zupan Electric, and part of the deal would allow Zupan up to two weekends from the date of the sale to remove those items.

The public auction will be held at the County Annex on Tuesday, May 21 at 3 p.m.

Zupan was in attendance at the commissioners' meeting and approached them with a complaint about loss of utilization of parking in the area of his business on Lane 3.

"When I was approached about this project I was all for it," Zupan said, "but it's a real hardship

Partial settlement reached in horse killing lawsuit

A U.S. District Court lawsuit pertaining to the Aug. 10, 2010, killing of a horse by a former employee of the Hot Springs County Sheriff's Office has resulted in a settlement from the former undersheriff involved in the shooting.

The lawsuit, filed by Chris and Larry Bentley as plaintiffs, names Hot Springs County Sheriff Lou Falgoust in his official capacity and former Undersheriff Dave Larson in his individual capacity as defendants. When the suit was originally filed in September, it only named Larson in his individual capacity as a defendant.

In a judgment filed April 10, 2013, U.S. District Court Judge Scott W. Skavdahl noted the formal offer of Larson to settle his part of the lawsuit for \$2,700 plus the plaintiff's attorney fees and recoverable court costs.

Skavdahl ordered Larson to pay the settlement and an amount that will later be determined by the court for the

recoverable court costs and legal fees. The Bentleys filed their initial complaint against Larson Sept. 26, 2012, which details the facts of Larson's in-

volvement of the killing of the horse, who was named "Bud" by the plaintiffs, and the contended damages incurred.

On April 2, the Bentleys filed a "first amended complaint" adding Falgoust, and by extension the Hot Springs County Sheriff's Office, to the lawsuit.

The plaintiffs contend the sheriff adopted deficient training, policies, procedures and customs that led to Larson's shooting of the horse. The complaint cites a deposition that took place March 13 where Falgoust testified about the sheriff's office's Animal

Killing Policy and peace officer training that was in effect at the time of the killing of the horse. A direct transcript of the deposition is currently

unavailable. According to the amended comlaint. Bentlevs contend the official policies of the department "were the moving force behind, and caused, provided for and/or tolerated commission of unconstitutional acts by its peace officers. These unconstitutional acts include but are not limited to: deprivation of private property, i.e. livestock, of Hot

Springs County residents without due process of law," the complaint reads.

The complaint seeks monetary damages for the contended violation of the Bentleys' Fourth and Fourteenth Amendment rights under the U.S.

The amended complaint asked for an award of compensatory and punitive damages, as well as attorney fees and incurred costs and any other relief the court deems just and proper. The complaint also demands a jury trial on all of the claims and factual issues.

Council approves Centennial funding

The Thermopolis Town Council approved a \$1,500 request from the Hot Springs County Centennial Committee to help cover the cost of the Centennial gunfighters entertainment and to provide disposable utensils, cups and plates for the Centennial barbecue in Hot Springs State Park. The Centennial Celebration is June 22.

The council had asked the committee to clarify a previous request made at a prior meeting regarding advertising funding for the event.

At a previous meeting, the committee approached the council with a wish list of advertising options, where the cost could

have reached up to \$12,000. Tracy Linko, a spokeswoman for the committee, said the com-

mittee has refined its advertis-

ing budget to \$3,940.

Linko said the committee plans to buy statewide advertising through the Wyoming Press Association and provide advertisements at local restaurants in time for major events such as the 3-on-3 Basketball Tournament.

The committee also plans to reimburse the Thermopolis Cowboy Rendezvous Committee for advertising resulting from the partnership.

Councilman Tony Larson suggested the town provide the full request because the town is not required to donate for Fourth of July fireworks this year. Last year, a fire ban prevented the Thermopolis Volunteer Fire Department from having the display, and the funds for the 2012 display may be used to cover the costs for the 2013

Mayor Bill Malloy insisted the committee work with the town attorney to draft a contract detailing the service to the town for the one-time donation.

The council approved the donation subject to the completion of the contract.

Street closure

Tom Williamson of Stop Light Pizza requested a road closure on Seventh Street between Broadway and Warren streets for May 4 in order to start a

summer concert series. The concert would last between the hours of 5 and 10 p.m. and would be completely shut down at 10 p.m. to lessen any noise impact on homes in the neighborhood, Williamson said.

event and raised about \$2,800 in net revenue. The figure does not yet include revenue from the Tiki Bar.

Board members said they heard positive feedback from attendees at the banquet and discussed ways to improve participation next year.

The board also discussed changes next year so that the chamber does not have as much leftover food. The chamber was able to donate leftover condiments and food to the Senior Center after the banquet.

Chamber members also received positive feedback on hosting the Harlem Ambassadors.

Moeller said the chamber sold more than 480 tickets to the event, but had only been expecting about 250 people.

Board President Meri Ann Rush said she was impressed with the school program earlier in the day made possible by help from the Greater Learning Foundation and all of the schools. The program was delayed a few hours due to the Ambassadors' vehicle sliding off the road while traveling over the Big Horn Mountains that morning.

She said the Ambassadors also impressed a good message on the children.

The chamber expected the venture to be a break-even event that would benefit the community, but the ticket sales yielded about \$900 in net-revenue for the chamber due to the large turnout.

Summer hours

The board discussed changing summer hours in order to target specific times where high tourist traffic is expected.

Last summer, the chamber opened earlier in May and stayed open during the weekends through mid-September.

The board discussed the number of people who came into the office between 8 and 9 a.m. and decided the low numbers did not warrant a change in opening times this summer.

Board members decided to make changes pending consultation with the Thermopolis-Hot Springs County Lodging Tax Board regarding funding for a summer position.

Starting the Friday before Memorial Day and ending the Monday of Labor Day, the chamber plans to be open from 9 a.m. to 6 p.m. Monday through Saturday and from 10 a.m. to 4 p.m. on Sundays.

The board also decided to suspend the chamber's Cash Mob program at least for the summer partly due to busy summer weekends and partly due to lack of participation.

Board member Dixie Vialpando suggested that if the board resumes Cash Mobs in the fall, it needs to rethink the program in order to make it more affordable and easier to attend.

Vialpando also discussed some of the early preparations for the Demolition Derby in August.

One of the topics was the need for volunteers for the annual event. Vialpando suggested writing a letter to member businesses asking the business to volunteer at least one employee for the derby.

She said the town has many volunteers who can work, but they don't realize that they are welcome at such an event. Some of the volunteer duties specifically mentioned included gatekeepers and ticket takers.

Vialpando also suggested the chamber provide locally bought T-shirts to the volunteers in order to thank the volunteers for their help.

The series would take place the first Saturday of each month in summer with different bands playing each month. He said the events will be alcohol-free and are meant to appeal to families and teenager audiences.

The council approved the sin-

gle road closure in May in order to gauge how the first concert goes before approving further closures.

14th Street project

The council approved a request from LAMAX Construc-

tion, Inc. to delay the start of the 14th Street water line replacement project until July 8.

The 14th Street project will replace older water line starting in front of the Thermopolis Volunteer Fire Department and head south to Canyon Hills

Road. The project will continue east on Canyon Hills Road until the intersection with Highway 20 South.

The reason for the delay is for the contractor to save money on insurance coverage by starting the 14th Street project imme-

diately following completion of the Broadway Street water line project versus working on both projects at the same time.

Engineer Anthony Barnett did not foresee any issues with the delay, and the council approved pushing back the start

date on the project.

The council has already given LAMAX notice to proceed on the Broadway Street project, which will start at Third Street and continue east until it crosses the Big Horn River and connects to East Thermopolis.
