## Centennial Celebration

#### Parade, entertainment, barbecue Saturday

You can expect wall-to-wall entertainment Saturday during the Hot Springs County Centennial Celebration in Thermopolis and Hot Springs State Park.

The county is celebrating its 100th birthday in a huge way, in conjunction with the annual Thermopolis Cowboy Rendezvous set for tonight (Thursday), Friday and Saturday. One of the components of the celebration is a free buffalo barbecue at 5 p.m. Saturday at the Kiwanis Washakie Shelter in the state park.

After the free Tumbleweed Propane pancake breakfast at the fair building to kick off Saturday's events, the Centennial portion of the weekend begins with the Cowboy Rendezvous/ Centennial Celebration Parade at 10 a.m. The route is the same as last year's parade, beginning where Shoshoni Street turns into Sixth Street heading for downtown Thermopolis.

Former Gov. Dave Freudenthal and his wife, U.S. Federal District Court Judge Nancy J. Freudenthal, will be featured as part of the parade.

Parade spectators are encouraged to stay downtown for the Centennial Celebration ceremony, which starts at 11 a.m. at Bicentennial Park at Broadway and Fifth streets. It will include the reading of proclamations by the county commissioners and Town of Thermopolis recognizing June 22 as Hot Springs County Centennial

## Lodging Tax Board, chamber to each have their own directors

The relationship dynamic between the Thermopolis-Hot Springs County Chamber of Commerce and the Hot Springs County Lodging Tax Board was fundamentally changed during a chamber board meeting Thursday, June 13.

The chamber discussed the status of its proposed fiscal year 2013-14 budget. Executive Director Amanda Moeller informed the board the Lodging Tax Board has decided not to fund \$14,000 in administrative reimbursement this year and that adjustments had been made to keep the budget "in the black."

The Lodging Tax Board has budgeted for advertising spending for its special events fund, which includes funding for the 3-on-3 Basketball Tournament, Demolition Derby, Gift of the Waters Pageant, etc., said Lodging Tax Board member Carl Leyba.

Lodging Tax Board Chairman Earnest Cummings explained his board has strived long and hard to figure out how to bring people to town and that room occupancy rates at hotels have been in decline.

Because of the decline, the lodging tax coffers have taken a hit – resulting in \$17,000 being cut from the lodging tax budget during the next fiscal year.

Cummings then explained that he had a recent epiphany regarding the way the town operates. He said the Town of Thermopolis is "doing it right."

"They're building it, the tourists will come," Cummings said.

Using the "Field of Dreams" analogy, Cummings stated the town is correct in focusing on infrastructure, leaving the work of marketing the town to the Lodging Tax Board, chamber, Fair Board and the Hot Springs County Eco-

nomic Development Co.

Cummings explained a Lodging Tax Board plan to hire/contract a person to focus 100 percent on tourism marketing while working in concert with the chamber to promote special events and common interests.

He said the Lodging Tax Board is giving the chamber an opportunity to focus 100 percent on businesses, educating the community in e-commerce and special events.

The Lodging Tax Board stressed that the strategy isn't to break up the two boards, but to strengthen both by relying on two people instead of one director.

#### Moeller resignation

Moeller also presented her resignation as executive director of the chamber during the meeting and lodging tax discussion. Moeller said that after careful consideration, she plans to take the position/contract offered by the Lodging Tax Board.

Regarding the new chamber director,

she stated the changes would take more than a 33 percent load off a new director, and that she will still be a resource to assist the chamber and its director. At the end of the meeting, the board

At the end of the meeting, the board went into closed executive session to discuss personnel.

#### **Chamber board** Several members of the chamber's

board of directors expressed interest in the new relationship and endeavor.

Board member Donna Nally said she thought the Lodging Tax Board was doing the right thing and that the chamber and the board can continue on their new paths together and build from it.

However, she expressed brief disappointment in losing Moeller as chamber director.

Board member Tom Butler asked and

expressed interest in the goal of the plan to "free up the chamber so that it is not as concerned or at odds with tourism." Board President Meri Ann Rush ex-

pressed the desire to continue a dialogue and suggested meeting sometime in July to brainstorm new ideas after completion of the Hot Spot Car Rally, Centennial Celebration and Thermopolis Cowboy Rendezvous PRCA Rodeo.

The Lodging Tax Board asked that if the chamber wants to keep the tourism office at the chamber, they request the chamber provide a proposal for office space rental within 10 days – to which the chamber board replied they would discuss the issue and get back to the Lodging Tax Board

participants must be at the fairgrounds no later than 5:30 p.m.

Admission to the race is free and participation is limited to 16 teams.

The rodeo action will get going at 7 p.m. Friday with gates opening at 4 p.m. for the first performance. Tickets to both perfor-

mances cost \$10 each night and will feature various rodeo events and special entertainment courtesy of trick rider Sally Bishop and rodeo clown and barrel man Justin Rumford.

# Commissioners declare drought disaster status

The Hot Springs County Commissioners passed a resolution Tuesday evening declaring a state of disaster due to drought and the agricultural impacts of drought.

In the resolution, the commissioners recognize that the agricultural community is suffering critical impairment in operation caused by drought, that the costs of support is more than the county resources available and that the conditions are predicted to worsen or continue into the future.

Accompanying the resolution is a formal letter to Gov. Matt Mead announcing the declaration of Hot Springs County as an Agri-Business Disaster/Drought Area and requesting him to begin the drought declaration process for Hot Springs County.

During the discussion of the resolution, commissioner Mike Baker said farmers and ranchers in the county indicated it had been a good start for grass this summer, but that there is not water available in the springs and reservoirs for livestock.

The commissioners also discussed a press release by the U.S. Department of the Interior Bureau of Reclamation indicating a revised percentage of 44 percent of a 30-year average as the forecast inflow into Boysen Reservoir from last April to July.

The bureau's release indicates 113,000 acre-feet of water flowed into the reservoir during April and May and that 137,000 acre-feet is expected for June and July.

#### Legend Rock

John Fish approached the commissioners to provide information on a possible plan to secure private

land in the vicinity of Legend Rock Petroglyph Site

in order to help manage and secure the site.

Fish explained the idea to swap land currently managed and in trust by the Bureau of Land Management (BLM) for the private land currently surrounding Legend Rock.

He said the private landowner is in favor of the swap, but the BLM has indicated the rangeland intended to be traded does not match criteria needed to make the swap equitable.

Fish explained the BLM wants to trade "apples for apples and oranges for oranges."

Commissioners received more specifics about the proposal before advising Fish to discuss the issue with BLM and state officials in Cheyenne.

Fish added that Legend Rock keeps developing without its own budget through community, independent and Hot Springs State Park support. He said it's a goal to make the site a jewel for the state as visitor numbers increase and more people come to see the historical site.

#### Trane update

The commissioners started their meeting with an update on the Trane Energy Project.

Dan Marshall of Trane said the project is currently being held up by pending approval from Rocky Mountain Power regarding rebates for the buildings. The rebates currently affect the Joint Law En-

forcement Center, courthouse, library and agriculture storage building.

Marshall's report indicated that pending approval from the power company, the project should be near

completion by July 1.

## **Hot Spot Car Rally** brings in 131 entries

The number of vehicles that vied for prizes during the 21st annual Hot Spot Car Rally on Father's Day was 131 vehicles. That was slightly down from 147 in 2012, but the rally competed with another Wyoming car rally during the weekend.

Cars, trucks and motorcycles from across the state descended on Hot Springs State Park for the two-day festival. The rally had three entries from Idaho as well as individual entries from South Dakota, Montana, Arizona, Oregon and Virginia Beach, Va.

David Burroughs of Virginia Beach received the Farthest Distance Award, traveling almost 2,000 miles for the rally.

The rally committee earned \$1,725 in the Pedal Car and Leather Jacket raffle. After holding other key positions, Freudenthal was appointed United States Attorney for the District of Wyoming. He was elected the 31st governor of Wyoming on Nov. 7, 2002 – serving two terms.

To begin the centennial ceremony, Harley Rhodes will sing our National Anthem and State Rep. Nathan Winters will offer a prayer.

Preceding Freudenthal's address, brief talks will be given by commission chairman Brad Basse, Winters and Sen. Gerald

Geis. A letter of congratulations for the county's centennial from U.S. Sen. John Barrasso will be read by field representative Pam Buline. Notes from U.S. Sen. Mike Enzi and U.S. Rep. Cynthia Lummis will also be read.

To wrap up the ceremony, evervone will be entertained by an "Old West gunfight" provided by a local group, the Smoking Waters Outlaws-right there in Bicentennial Park, under the direction of Belinda Moore. That will be just a taste of what can be witnessed during an afternoon of entertainment at the state park pavilion.

Deb Mount, owner of Needful Things, recently purchased the business and remodeled, adding an old-fashioned bar in the back as well as tables and chairs.

"All of our shakes are made from premium, old-fashioned hard ice cream," Mount said. "We have the traditional strawberry, chocolate and vanilla and about 10 other different flavors."

Some of those flavors include Chunky Monkey, Thin Mint, Dreamsicle and Butterfinger, all blended with 10 scoops of ice cream.

"We barely put any milk in," she laughed. "Just enough to keep the blenders from burning up. They're so thick you can stand a spoon up

Mount said if anyone remembers the shakes that used to be available in Shoshoni, these would be very similar.

"They're not only thick, we'll be adding fruits and puddings and things to enhance the flavors. They'll be unique with a distinct taste," she said.


