One opening is available on the fair board, an unexpired term that ends in 2018.

If you are interested in applying for any of these appointed positions, please pick up an application at the county clerk's office or online at hscounty.com.


Applications must be turned in to the clerk's office no later than 5 p.m., Jan. 30.

## Future of Hot Springs State Park

The Hot Springs State Park Master Plan Steering Committee met for the first time Monday to discuss the purpose of a master plan for the state park, and to discuss issues and opportunities that the park has.

The purpose of the meeting was to start talking about what the future for the state park should be. Approximately 20 local business owners and residents make up the committee.

The master plan for the state park should take around 15 months to complete. Having started work in Sept 2014, the master plan should be completed by the end of 2015.

There is a need for a new master plan because of multiple reasons, one of which is the fact that the last master plan is more than 30 years old having been finished in 1984.

Among the biggest concerns during the meeting was a need to improve parking in Hot Springs

Dan Moriarity, of TeePee Pools, said in some cases a single RV or Camper could cause a huge

parking problem in the park. The group also discussed improving the signage on the roads outside of town so more tourists passing through town know that the state

park is nearby and assessable to them. Committee members agreed unanimously that currently there are few signs that lead people to the park, and fewer still that are very specific.

Another possible change that could be in store for the park would be an additional entrance. There has not been any specific location cho-

The master plan may also include improvements to the current entryway to the park, along with other improvements within the park.

Community activist Amanda Moeller said one of the biggest comments she hears from park visitors is that nothing has changed in the park in 30 years. However, she added that those comments have been both positive and negative.

While the park's master plan is still in the early stages of conception, the community as a whole has been asked to share their thoughts and opinions on what they would like to see the master plan look like during an upcoming community workshop

A Community Open House will be held on Jan. 26 from 6 p.m. to 8 p.m. at the Fire Hall at 400 South 14th St.

The next meeting of the steering committee will be Feb. 12.
