

Chimenti noted he enjoyed in his church — the Community Church having more contact with people as a member of the police shift work.



Pursuant to Tariff Schedule 93, the Company is proposing to refund to customers approximately \$644 thousand to account for calendar year 2015 balancing account adjustments and 2016 forecast sales revenues for REC and SO2 products in the market. From the currently approved \$690 thousand surcredit, this results in an overall increase of \$50 thousand from current rates.

RMP is also requesting a change to the filing date and rate effective date for future filings beginning in 2017. The current filing date is March 15 and the request is to change it to April 15. The current rate effective date is May 15 and the request is to change it to June 15.
