COUNCIL PROCEEDINGS

The Thermopolis Town Council met in regular session October 3, 2017 at 7 pm at Town Hall. Present were Mayor Pro-tem Dusty Lewis, Council members Tony Larson, John Dorman Sr. and Bill Malloy. Also present were Mayor/Codes Administrative Assistant Fred Crosby, Clerk/Treasurer Tracey Van Heule, Public Works Director Ernie Slagle, Police Chief Steven Shay, Town Engineer Lisa Johnson and Town Attorney Hope Mead. Mayor Mike Mortimore was absent.

AGENDA: Following the pledge of allegiance, Dorman made a motion, seconded by Larson and carried to approve the agenda as written.

MINUTES: Larson made a motion, seconded by Malloy and carried to approve the Council meeting minutes from September 5 and 19, 2017.

BILLS: Malloy made a motion, seconded by Dorman and carried to approve the General, Enterprise and Special Fund bills for September 2017. Larson abstained on the approval of the bill to his business.

CITIZEN PARTICIPATION: PEOPLE FOR PEOPLE: STREET CLOSURE: Kelly Andreen on behalf of People for People asked for street closures on Saturday December 9, 2017 for the Downtown Spectacular. She asked for the north side of Broadway to be closed from 4th to 6th street and a half block of 5th street from the alley to Broadway from 9 am to 9 pm. The event will feature tours of vintage campers, sheep wagons and a tree festival.

CITIZEN PARTICIPATION: RAY & BELINDA MOORE: UPPER FREMONT STREET: Ray and Belinda Moore again expressed concern about the ground water in upper Fremont Street. Following discussion the town engineers were directed to prepare cost estimates to install a leech line from the area to the storm drain. Slagle noted the upper storm drain had been cleaned.

TOWN ENGINEER: LISA JOHNSON: Johnson presented pay estimate #1 and change order #1 for the Chip Seal Project. The pay estimate was approved in the list of bills. Dorman made a motion, seconded by Malloy and carried to approve change order #1, which increased the contract by \$1,728.78 for additional materials. Johnson updated the Mayor and Council on the completion of the chip seal project, the airport tank painting and the water leak on the 12th Street sewer project.

DEPARTMENT REPORTS: Police Chief Steven Shay presented September reports for this department and noted a radar feedback sign had been ordered. Public Works Director Slagle presented September reports for his departments. Codes Administrative Assistant Crosby noted there have been numerous inspections on the Maverik project.

TOWN ATTORNEY: HOPE MEAD: THIRD READING OF AN ORDINANCE TO INCREASE SEWER AND SOLID WASTE RATES: Following the third and final reading of the ordinance, Dorman made a motion, seconded by Malloy and carried to pass the third and final reading of the ordinance. For Thermopolis residential customers the base rate will increase from \$71.00 to \$75.00. There will be corresponding increases to business rates and out-of-town customers.

ORDINANCE NUMBER 849

AN ORDINANCE INCREASING THE SEWER AND SOLID WASTE COLLECTION RATES FOR USERS WITHIN AND CUSTOMERS OF THE TOWN OF THERMOPOLIS, WYOMING BY REVOKING ORDINANCE NO. 826 AND REVOKING RESOLUTION NO. 493 AND 500 AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Town finds that the costs of utility services provided by the Town of Thermopolis has increased and that the Town needs to raise additional funds for the operation of the Town facilities and collection systems as well as debt payment of new construction and that prudent fiscal management mandates that the Town raise and receive funds for the services provided to the Town residents and customers.

NOW THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF THERMOPOLIS:

Section 1. Rates for collection and treatment of waste water are hereby established as follows:

(a) The wastewater charges for commercial or nonresidential users outside the corporate limits of Thermopolis shall be the same factor/multiplier multiplied by the charge to the

residential user outside the corporate limits of Thermopolis. Each month, all residential and commercial users will also be charged \$1.00 per thousand gallons of treated water used based on an average of the monthly treated water usage in the preceding months of December, January, and February, with a minimum charge per month of \$2.00.

(b) In addition to the wastewater usage charge, within the corporate limits of Thermopolis and East Thermopolis, the base rate for residential units shall be \$25.00.

(c) In addition to the wastewater usage charge, outside the corporate limits of Thermopolis and East Thermopolis, the base rate for residential units shall be \$36.50.

(d) The base rate for commercial users will be a multiplier of the residential in-town or out-of-town base sewer rates found in the schedule on file with the Town Clerk.

(e) New utility accounts without a history of treated water usage during the months of December, January, and February, will be charged the city wide average of 4,000 gallons for a monthly wastewater usage charge, until an average usage history has been established.

(f) A schedule of rates computed pursuant to (b), (c) and (d) is on file with the Town Clerk.

Section 2. Rates for solid waste collection of residential and commercial users shall be established as follows:

(a) The monthly charge for sanitation services in the form of solid waste collection for a residential dwelling unit shall be \$21.00 per month.

(b) The monthly charges for commercial solid waste collection shall be:

Section 3. Ordinance No. 826 and Resolution No. 493 and 500 are hereby revoked.

Section 4. This Ordinance shall take effect on the 1st day of November, 2017, after being published in the Thermopolis Independent Record as required by law.
