Pursuant to the Wyoming Administrative Procedure Act and the Wyoming Public Service Commission's (Commission) Rules, the Commission hereby gives notice of the Application of Wyoming Gas Company, a division of Natural Gas Processing (Wyoming Gas or the Company) for approval to revise the Wobbe Index for its Grass and Lake Creek distribution areas, as more fully described below.

Wyoming Gas is a public utility as defined by Wyo. Stat. § 37-1-101(a)(vi)(D), subject to the Commission's jurisdiction pursuant to Wyo. Stat. § 37-2-112.

On December 29, 2017, Wyoming Gas filed its Application for approval to revise the Wobbe Index for its Grass and Lake Creek distribution areas. The Company is requesting to revise the Wobbe Index for its Grass Creek distribution area from 1389 to 1324, and the Lake Creek distribution area from 1381 to 1312. Both revisions are based on a historic 12-month weighted average. The Application is filed in accordance with Commission Rule Chapter 3, Section 1(c)(v)(C).

This is not a complete description of the Application. Interested persons may inspect the Application at the Commission's offices in Cheyenne, Wyoming, and at Wyoming Gas' office located in Worland, Wyoming.
