PUBLIC NOTICE

The Wyoming Public Service Commission (Commission) has approved the Application of Wyoming Gas Company (Wyoming Gas or the Company) to pass on to its customers a net wholesale natural gas cost increase of \$0.0440 per CCF, effective for usage on and after October 1, 2020. The total volumetric rate increase of \$0.0440 per CCF is attribut-

able to a projected natural gas cost increase of \$0.0715 per CCF to the Purchased Gas Cost, and a credit in the CBA of \$0.0275 per CCF. This approval is subject to notice, protest, intervention, refund, change, investigation, opportunity for hearing, and further order of the Commission.

The average residential customer using approximately 78.1 CCF per month may expect a monthly gas bill increase of approximately \$3.44 or 6.1%, before taxes. Actual bills will vary with usage.

Commission Rule Chapter 3, Section 26 allows a utility to pass on to its customers known or projected commodity cost increases or decreases on a dollar-for-dollar basis, subject to public notice, opportunity for hearing and refund.

Wyoming Gas' Application is on file at the Commission's offices in Cheyenne, Wyoming, and in the Company's Worland, Wyoming business office. Interested persons may inspect the Application during regular business hours.

Anyone desiring to file an intervention petition, request for a public hearing, statement, public comment or protest in this matter must file in writing with the Commission on or before November 9, 2020. The petition shall set forth the grounds of the proposed intervention or request for hearing and the position and interest of the petitioner in this proceeding.
