Freund added, "I almost want to think it's similar to gambling. You know, you give them a little bit of positive reinforcement and they feel good. They feel good about that. They're going for this and they just focus on what the end result is, what they're hoping to get. The jackpot is \$500,000. I want that. I'm going to keep spending \$5 on a lottery ticket over and over because I know I'm going to get that. And that's, I think, just the psychology of the game that they play of, 'You know, you're so close. We've almost got you there. This happened. It was unexpected. You know, none of this is ever planned. And if you stop now, you're going to lose everything' and that's sort of the psychology that I think on that large-scale one that was played."

Deputy Freund emphasizes verifying your sources. Check the domains of the website. Contact the Better Business Bureau. Contact Law Enforcement sooner than later.

The FBI at their IC3.gov website provides helpful information on what to look out for. They state, "Perpetrators Use Various Methods to Deceive and Defraud Elderly Victims For Financial Gain."

"Each year, millions of elderly Americans fall victim to some type of financial fraud, racking up more than \$3 billion in losses annually. Criminals use a variety of methods to deceive these victims, including romance, sweepstakes, charity, technology support, grandparent, lottery, and government impersonation schemes, to name a few. In each case, perpetrators try to gain their targets' trust and may communicate with victims via computer, through the mail, in person, and by phone, TV, and radio. With the elderly population growing in the United States, it is likely perpetrators will find more and more victims.'

Once successful, perpetrators will likely continue to target vulnerable elderly victims with these schemes because of the prospect of significant financial gain.

On the IC3 website, the FBI also provides advice through Defense and Mitigation. They offer tips regarding recognizing a scam, how to avoid it and what to do if a perpetrator gains access to your information or device.

If you believe you or someone you know may have been a victim of elder fraud, you should contact your local FBI field office. You can also file a complaint with the Internet Crime Complaint Center at www.ic3.gov.

Deputy Freund and the Hot Springs County Sheriff's office are available to help victims file fraud complaints. If you need to contact them, call 864-2622.

Mandate

She was joined by Judge Julia Smith Gibbons, a nominee of President George W.

Critics of the directive say OSHA is not authorized to make the emergency rule, partly because the coronavirus is a general health risk and not exclusive to the workplace.

If the mandate moves ahead, it is set to go into ef-

fect Jan. 4 and is estimated to cover 84 million people. OSHA has announced it will not issue citations for violating the rule until Jan. 10.

At the time the Wyoming Legislature held its special session, the mandate's rules and regulations had not yet been released, making it difficult to legislate against.

Ultimately, the session ended with a bill that does little more than allocate \$4 million towards fighting the mandate in court.

Wyoming and a litany of other states are also fighting mandates pertaining to federal contractors, certain National Guardsmen and health workers in facilities that take Medicare or Medicaid funding.

Some of these challenges have been successful so far, leading to pauses in certain parts of the nation.

Skelton thanked Axtell and echoed her comments by saying he "learned a lot" during his past two years as vice-chair.

Weyer nominated Axtell to serve as the new board vice-chair, while Engelbrecht nominated Martinez, and Van Antwerp nominated Farrell, causing Engelbrecht to joke, "Let's just split the vote," drawing laughter from the board.

Axtell and Weyer voted for Axtell as vice-chair, while Martinez and Engelbrecht voted for Martinez, and Van Antwerp, Skelton and Farrell voted for Farrell, making him the winner of a second 3-2-2 split.

Both Van Antwerp and Weyer nominated Martinez to serve as the new board clerk — "You should sign your daughter's diploma,' Weyer told Martinez — and after no one else was nominated, the board voted unanimously for Martinez.

Likewise, when Axtell nominated Weyer to serve as the new board treasurer, no one else was nominated and the board voted unanimously for Weyer.

When it came time to declare potential conflicts of interest, Hunt reminded the board that his spouse works for the school district, while Martinez noted his spouse works at the middle school as a teacher, and Skelton

reiterated his "temporary employment at RYTE Rehab," which he added ended that day.

Weyer pointed out her husband works through the hospital, while Van Antwerp,

Engelbrecht and Axtell all reported "no known conflicts' of interest.

And the board again approved purchasing a bond in the amount of \$50,000 for the board treasurer.

COUNCIL PROCEEDINGS The Thermopolis Town Council met in

regular session December 7, 2021, at 7 pm at Town Hall. Present were Mayor Mike Chimenti, Council members Tony Larson, John Dorman Sr., Bill Malloy and Dusty Lewis. Also present were Mayor/Codes Administrative Assistant Fred Crosby, Clerk/ Treasurer Tracey Van Heule, Public Works Director Ernie Slagle, Town Engineer Anthony Barnett, Police Chief Pat Cornwell and Town Attorneys Mike Messenger and Marshall Keller.

AGENDA: Following the pledge of allegiance, Larson made a motion, seconded by Dorman and carried to approve the agenda as written.

MINUTES: Malloy made a motion, seconded by Lewis and carried to approve the Council meeting minutes from November 2 and 16, 2021.

BILLS: Larson made a motion, seconded by Lewis and carried to approve the General, Enterprise and Special Fund bills for November 2021

CITIZEN PARTICIPATION: MICHAEL WRIGHT: 2021 AUDIT RESULTS: Wright presented a brief synopsis of the audit, noting a change in accounting standards resulted in the Revolving Loan Fund being listed with the General Fund. At the Town's request, the Nicholson Trust fund is not combined as above. Wright noted the financial statements are presented fairly (a clean opinion), with the yearly comment on the lack of segregation of duties. Larson made a motion, seconded by Malloy and carried to accept the 2021 audit. Wright noted he is retiring and the firm will no longer perform audits.

Larson made a motion, seconded by Dorman and carried to allow the Mayor to sign the paperwork. Barnett also reviewed the upcoming water line project on upper Fremont and Peppermint and noted the Public Works Director would like to replace the sewer line, which is also in the street. Following discussion, Larson made a motion, seconded by Lewis and carried to add the Peppermint Street sewer line replacement to the bid.
