Notice of Availability of the Administrative Record for a Time-Critical Removal Action – Gebo Wire Burn, Hot Springs County, Wyoming

In accordance with the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) 40 CFR 300.415(c)(n)(2), on May 19th, 2022, the Bureau of Land Management (BLM) Worland Field Office will begin accepting public comments on work to perform a CERCLA Time-Critical Removal Action (TCRA) at a contaminated illegal wire burn site known as the Gebo burn Site. The site is located in Township 44 North, Range 95 West, Sections 7, 8, 9, 10 in Hot Springs County, Wyoming, approximately 23 miles southwest of Worland or 11 miles northwest of Thermopolis.

Soil contamination at the Gebo site is due to an illegal wire burn; large spools of copper wire were burned to remove the insulation surrounding the wire resulting in heavy metals being released into the soil. The site has had a previous soil cleanup effort conducted but an area of roughly 3,500 square feet of shallow soil contamination remains and needs to be removed. Prior to the start of the TCRA, Gebo road will have two sections repaired, thereby allowing heavy equipment access for soil removal.

Constitutional Amendment A

The Wyoming Constitution allows the state to invest state funds in equities such as the stock of corporations, but does not allow the funds of counties, cities and other political subdivisions to be invested in equities. The adoption of this amendment would allow the funds of counties, cities and other political subdivisions to be invested in equities to the extent and in the manner the legislature may allow by law. Any law authorizing the investment of specified political subdivision funds in equities would require a two-thirds vote of both houses of the legislature.

Constitutional Amendment B Currently, the Wyoming Constitution re-

quires Wyoming Supreme Court justices and

Chairman Ryan led those present in the Pledge of Allegiance.

Approval of Agenda – The agenda was approved with the addition of Other Business Item 6. Appointment of Predator Control Board member.

Approval of Minutes – The minutes of March 15, 2022 were approved as presented. GIS Report - T-O representatives joined the meeting by phone to give the monthly GIS report. Work continues to map County road easement and right-of-way descriptions to link to historical documents. Work with the Planner continues to incorporate land use change records/documents into the GIS hub and to develop an on-line land use classification application. Held a work session with Road & Bridge to review desktop applications, test mobile application for maintenance layer and training in these applications. The ArcGIS Online credits have been purchased.

FBO Monthly Report – There were 204 total recorded operations in March. Fuel sales included 579 gallons of AvGas and 1522 gallons of Jet fuel. The Civil Air Patrol squadron came down from Powell to do some training flights for their cadets. An engineer from Morrison-Maierle came out on behalf of WYDOT Aeronautics to get a linear measurement for the upcoming crack seal project. WYDOT is trying to get all the crack seal projects in the Basin back on the same schedule after the pandemic disrupted the schedule for some airports in the last couple of years. The solar batteries for the roadside airport sign are not working again. Alternative power sources are being investigated. The FBO presented a document listing the dimensions of aircraft requesting transient hangar space for discussion.

Maintenance Monthly Report – The Commissioners accepted a bid from Wyoming Roofing in the amount of \$122,605.92 for the Fair Building Roof Project, contingent on the engineer's review and approval. The Courthouse roof project pre-construction meeting was held March 21st. Construction began on March 30th. A full asbestos layer was discovered on the Courthouse roof, requiring more remediation than anticipated. Regular emails will be sent to courthouse office leads updating them on construction activities as the project progresses. Maintenance personnel are drilling holes through concrete to facilitate cable runs for the camera project in the LEC. There was a sewer line break in the LEC above dispatch. Repairs will be made as quickly as possible.

Road & Bridge Monthly Report - The Road & Bridge Supervisor met with the WYDOT engineer on the Grass Creek Road section the County will be assuming responsibility for as part of the Black Mountain Road project. Of the 61 culverts on that section, 27 of them need to be replaced. WYDOT committed to bringing this section of the road up to standard prior to the turnover. Part of that work will include culvert replacement and cattle guard replacement/leveling up. Mr. Rankin is working with Bill Gordon on a grant to replace the analog radios in the R&B department with WyoLink-ready radios. Cody Hensley has been hired for the department vacancy. The large culvert on Cottonwood Road is severely deteriorated and will be replaced as soon as materials can be obtained. Funds for this repair will come from the SCRF funds. The currently leased grader will be purchased for ther buyout price of \$230,000. The County will enter into a three-year lease for a new grader. The old CAT grader will be traded in. The new annual lease payment will be \$26,374, with an end of lease buyout of \$270,000. The new pickup purchased on bid last July will not be delivered this budget year, due to supply chain problems. The manufacturers have cancelled all government orders, so the process will have to start over if a new pickup is to be purchased in the next budget year.

Planner Monthly Report - The Natural Resources Planning Committee (NRPC) met twice last month and finished the rewrite of the Natural Resource Plan. The Land Use Planning Commission met on March 16th to generate proposals for amendments to the Land Use Plan, which have been forwarded to the Commissioners for review. The LUPC will be holding public hearings on two land use change requests this month. Their recommendations should be forwarded to the Commissioners for final hearing in May.

THP Brownfields Work – The DEQ has appropriated additional funds for more remediation work this summer. Septic Systems - The 2021 Septic System report has been submitted to the State. There are several outstanding permit applications with no current activity. The DEQ permit for the existing septic systems on the DuFour property has been approved by the DEQ, so the matter will come before the commissioners again on April 19th.

Emergency Management Monthly Report – The Emergency Management Coordinator reported he has nearly finished the County Emergency Operations Plan. When it is finished, it will be reviewed by the emergency responders and the County Attorney, and then presented to the Commissioners for review and signatures. Upcoming events include a Severe Weather webinar, a Statewide Emergency Manager meeting in Casper next week, and the Local Emergency Planning Committee meeting at the Fire Hall on May 4th at 1:30 p.m. The LEPC meetings are open to the public. The current focus is on the Boysen Dam Break Evacuation Plan.

Public Health / Prevention Monthly **Report**-The Public Health Nurse Manager noted this is National Public Health Week. Hot Springs Public Health has received three recognition awards in the last year for their immunization rates. The fourth CO-VID shot (second booster) is now available. Outreach clinics will be held for those 50 and older going forward. Hot Springs Public Health is currently ranked third in the state for COVID vaccination rates. 50.8% of county residents are fully vaccinated at this time. Prevention – Jennifer Cheney is working to expand coalition participation within the community. The annual plan is due in May. A major focus of the coalition at this time is trying to get a tobacco cessation person on board locally to help with tobacco use prevention. The next coalition meeting is April 13th.

Youth Alternatives Monthly Report - The Youth Alternatives Director reported there are currently 17 participants in the program – 10 males and 7 females, with 5 new citations. There are also 5 youth enrolled in HiSet, with two more scheduled to enroll. The monthly prevention class was "Guy's Night Out". The next Alive at 25 class will be held April 22nd. The Commissioners approved an Articulation Agreement between Central Wyoming College, the Help Center at Common Ground and Hot Springs County, contingent on the County Attorney's review and approval. The purpose of the agreement is to clarify roles, expectations, and responsibilities between CWC and CGHC/ YA for the delivery of HISET preparation/ testing services.

Weed & Pest Request for 2nd Mill <u>Levy</u> – The Commissioners approved the Weed & Pest Control District's request for the additional one mil on the County's assessed valuation for mosquito abatement.

Courthouse Landscape Grant -<u>Matching Funds Request</u> – The Commissioners approved the Red Dirt Master Gardeners' request for \$500 in grant match funds for the Courthouse Landscape project. Funds to come from the Maintenance budget.

Consider Liquor License Proposal -The Commissioners awarded a liquor license to SonRise Operations LLC. NOTE: After this meeting, it was determined that the proper application procedure had not been followed, so the award was suspended until the full process is complied with.

Other Business - State Parks Emergency Vehicle Operations Course Hold Harmless Agreement – The Commissioners approved the use of the old airport site by State Parks personnel for their Emergency Vehicle Operations Course on April 13, 2022. Wyoming Health Fair 2022 HSC Employee Wellness <u>Contract</u> – The Commissioners approved the 2022 Wellness Contract with Wyoming Health Fairs for HSC employees and spouses to participate in the Wellness Blood Draw on May 13, 2022. Participants will receive a break on monthly health insurance premiums. ARPA Workshop Schedule – The Commissioners scheduled a work session on April 19th with the Clerk to review the narrative to accompany the ARPA Grant funds report. Ad Valorem Transition Loan <u>Discussion</u> – The Commissioners asked the Clerk to notify the state that there is the possibility that some County entities may be interested in applying for the Ad Valorem loan funds. Clerk Kersten will send a letter to the Special Districts regarding their need for loan funds.

a little bit where we're being put in a position to make a legal decision on that easement. None of us are lawyers. None of us are land experts."

Planning commission member Merrill Ready said that he wanted to know more information about the easement and that he couldn't move forward with the application. Typically, the planning commission goes through a checklist that scores the application and helps determine if they should recommend or not to the county commissioners. The problem of the easement uncertainty did not allow the planning commission to start the checklist.

After further discussion, Ready mo-

tioned to table the application until Lane 14 access was settled or another proposal was made. Commission member Harvey Seidel seconded. Estenson said that the other proposal could be a different plan of access or if their plat mapping could be adjusted to allow an alternative route or any other idea of a Plan B.

The planning commission will meet again on May 18 to do a work session with no action to be taken.

The purpose of this session is to have the commission go over the application so that they can give Hayek further direction. Hayek is not expected to attend that work session.

Pops concert

Hot Springs County High School presented a pops concert last week in the school auditorium. This is band and choir director Drew Brown's last year with the school district.

Barb Rice gave the Youth Alternative report and said she has 18 total juveniles in the program with nine being released and five females and four males.

Bill Gordon gave the Emergency Management report and said that Kirwin snow tell is "looking good" and that "more water will be coming into the lake than they need to fill it." Gordon praised the recent precipitation and added, "springtime saved the day." Gordon provided a graph to the commissioners that showed the current snow water equivalent at Kirwin and that the current data is similar to the median historical measurement.

There were three public hearings during the commissioner's meeting. The first was regarding the county district and precinct changes for Resolution #2022-4. Representatives from both the Democrat and Republican parties were present. County clerk Becky Kersten presented the resolution of how there would be some shifts in some of the voting districts and precincts. During public comments, Jean Skelton voiced opposition as the changes in redistricting would not represent the rural population proportionally within the county Central Committee as one precinct has a small amount of representation of 18 voters and the other would have a larger amount of 140 voters. Democrat Levi Shinkle voiced support for the resolution stating it would increase their representation. Republican Cynthia Garbin also voiced support for the resolution. The commissioners voted and approved the resolution. The matter is to be readdressed again in 10 years unless the commissioners choose to do it sooner.

The second public hearing was regarding the SonRise Land Use change from agricultural to commercial so that a USDA-certified meat processing facility would operate. There were three conditions for the change. First, the commercial use would solely be for meat processing purposes. Second, the solid waste would be removed regularly and the materials would be covered. Third, the septic system permit would be approved by the DEQ. There were no public comments. The commissioners voted and approved the land-use change application.

The third public hearing was regarding the SonRise liquor application. There were no public comments given. The commissioners voted and approved the issuance of the liquor application.

Both commissioners Tom Ryan and Phil Scheel praised and thanked Douglas Lindamood for properly going through the application and approval process.

Bo Bowman for the Planning report introduced the ROW amendments for the Hamilton Dome Road and the East Cottonwood Road. Bowman noted that it took three years to complete the process of the amendments. The commissioners voted and approved to accept the amendments.

Bowman also reported that the NRPC's draft document is the HSC Natural Resources Management Plan, which will replace their 2014 Natural Resources Plan. It sets policies for the use of state and federal lands. The 30day public review period started on 4-28, and runs to 5-27, with a public hearing to receive oral comments on the evening of 5-25.

Additionally, Bowman said the LUPC's document consists of several revisions to Chapters 2 and 4 of the 2020 HSC Land Use Plan, which addresses land use on private land in the County. Most of these proposed changes address the short-term rental of homes and accessory residences in the County's Residential Land Use Category. The 30-day public review period will start on 5-12, and runs to 6-11, with a public hearing to receive oral comments on the evening of 6-15.

During some discussion with the commissioners, they motioned and approved a request for rock material from the Wind River Canyon to use for landscaping purposes.

The commissioners voted and approved to sign a letter for the BHBNDC. The county approved them using T-O Engineers as a consultant for their projects.

The commissioners appointed Quinton Hetzel, Cathy Titmus, and Matt Ryan to the South Thermopolis Water and Sewer District (STW&S). Chairman Tom Ryan abstained from the vote. The commissioners appointed these individuals for a term beginning May 3, 2022, and ending on November 30, 2022, at which time STW&S will hold elections.

The commissioners rescheduled their August 16 meeting and moved it to Thursday, August 18, at 3 p.m. There was a schedule conflict with the Federal Legislative Tour on August 16 and, therefore, moved.

Regarding an MOU for Wyoming Pathways for the Roundtop / T-Hill trail, Dusty Lewis talked to the commissioners. After discussion, the end result was that they reversed course from previous opposition and approved signing the MOU contingent upon the insertion of verbiage clarifying the lack of a permanent easement and emphasizing the fluid location of the trail. All of that is subject to approval by the county attorney.
