Chamber board report

by Jurri Schenck At the August Thermopolis-Hot Springs Chamber of Commerce board meeting held at Big Horn Federal, under old business CEO Meri Ann Rush reported on the July 25 Meet the Candidates Forum which was held at the Middle School.

Rush said it was well attended, however, there was some "push back" about allowing people to read letters on behalf of absent candidates because of the length issues. Candidates were limited to two minutes in their speaking times.

There was also a discussion about having the event be video broadcast. Rush said she spoke with Range and they had a lack of employees, which hindered them from helping. The next Meet the Candidates Forum will be on September 26 at the Thermopolis Middle School.

Rush and the board discussed how the event is useful to give candidates and the public a chance to meet and talk to each other. There was a suggestion that absent candidates could Zoom in remotely instead of having a letter read, if possible. However, Rush and the board were surprised and impressed by the turnout.

Regarding the 2022 Get Out with your Family Activity, Rush reported that there is still one more undiscovered buffalo doll for the activity. Rush also said some people were following her, trying to observe where she would hide the buffalo dolls. As part of the fun, if you find one and take it back to the chamber office, you can win \$100 in Chamber Bucks. The event is from July 15 to August 21.

Rush also reported on the Pageant Day Parade on August 6 and said that because of the rain that day many people wondered if the event would happen. Rush said that there were 39 entries in the parade and that there were half political and half non-political.

At the time of the board meeting, the Demolition Derby had not yet happened. It occurred on Saturday, August 13. Rush said it was "coming together" and the volunteer effort "was great".

Under new business, Rush said that the coming Chamber Banquet on October 1 will have the theme "Happy Fall Y'all" and the planning is "coming along."

Also discussed was the recent meeting Rush and Chamber President Howie Samelson had with the Travel and Tourism Board on July 20. Rush and Samelson had sent a letter to the Tourism Board requesting \$7,000 in wage reimbursement, which previously was \$6,000. The reason for the increase was due to inflation and the cost-of-living expenses increasing. The matter is still being worked out between the Chamber and the Tourism board.

Samelson and Rush reported on behalf of Main Street Thermopolis about their recent movie night on Tuesday, August 9. Samelson said there were 25-30 members there along with children and they watched the cartoon movie Bugs Bunny 1001. There is a scene in the film where the characters mention Thermopolis. They sat on chairs and on the grass. Samelson and Rush said "It went well" and "the kids want it again.

In the Director's Report, Rush said that on September 27 the Main Street Workshop will be held. Also, on September 28-29, the Wyoming Working Together Workshop will be held. Both events will occur in Sheridan.

The next Chamber meeting will be on September 8
