The Hot Springs Board of County Commissioners met in regular session on Tuesday, September 5, 2023, at 9:00 a.m. in the Public Meeting Room at the Government Annex Building. Present were Commissioners Tom Ryan, Phillip Scheel, and Paul Galovich. Also present were County Clerk Becky Kersten, and Administrative Assistant to the Commissioners Connie Guntly. Chairman Ryan led those present in the Pledge of Allegiance.

<u>Approval of Agenda</u> – The Commissioners adopted the agenda with the following changes:

ADD Ratification of Warrant # 64925.

Approval of Minutes - The Commissioners approved the minutes as presented from

the August 15, 2023 meeting.

Approval of Bills - AP Warrant Register - The A/P Warrant Register for bills totaling \$587,593.71 was submitted for approval (see end for listing), Commissioner Scheel will recuse himself from Warrant # 65003, payable to Tumbleweed Propane. The Payroll for August - \$197,214.32. The Commissioners approved the A/P Warrant Register.

Ratification of Warrant #64925 - A special bill totaling \$200,492.12 for the purchase of the Ingles property on Highway 20 was submitted for ratification. The Commissioners ratified all three Commissioners' signatures on the Special Bill Warrant number 64925, in the amount of \$200,492.12.

GIS Update - Ardurra completed the distance to the nearest intersection analysis for HSC road features, and provided support for the Road Maintenance Dashboard and made edits to the Septic Permit and Land Use Change Look Ups. In September work will begin on the NextGen911 layers, Ardurra may wait until the State releases their NextGen 911 information to make sure everything aligns. Ms. Ross stated work will begin on the County Road Topo, which will set priorities for roads and begin downloading FEMA LiDAR.

FBO Monthly Update - There were 318 total recorded operations in the month of August, with 2,541.01 gallons of Avgas and 3,354.4 gallons of Jet Fuel sold. The Seal Coat and Mark Project is complete with the exception of the paint that is scheduled for the 19th or 20th of September. Mr. Messenger reported Ardurra completed the inventory standards for WYDOT and the only non-standard item was the runway edge angles, which is common for Wyoming airports because the tolerances are tight. Chairman Ryan and Mr. Messenger attended the WACIP meeting and changes have been made which will be approved later in the meeting. The Fly-In is set for September 16th from 7:00 a.m. to 11:00 a.m.

Road and Bridge Monthly Report - The re-gravel project on Buffalo Creek Road is finished. Blading and mowing has been completed throughout the County as well as cleaning out culverts and cattle guards. Mr. Rankin reported he is advertising for a crew member position, the advertisement ran in the paper once and will run again for another 4 weeks. Mr. Rankin presented the High Risk Rural Road Application to be signed by the Chairman. The Commissioners approved the application for the High Risk Rural Road grant for guard rails on Missouri Flat Road in the amount of \$109,510 with a County Match of 9.51%. The Commissioners approved Chairman's signature on Approach Agreement #2023-0004 for Jim Crandall on Rim Rock Drive, no culvert is needed and all fees had been paid.

Maintenance Monthly Report - The tree trimming will be started in October. Mr. Dorman stated he has a quote from Fred Vega, who is the only person in the area that will do the stucco for the Senior Center, it is about \$15,000 to do the two walls. Mr. Dorman stated he does not have it in his budget. Chairman Ryan stated it should be done, and the funds can come out of emergency repair. Mr. Dorman also presented a proposal from LONG to do the BAS system in the Annex building, which will get rid of the Johnson Controls system, the amount would be \$50,000. Commissioner Scheel suggested Mr. Dorman get started on reviewing the Procurement Policy, speaking with Dean about the system and explaining all this before approval.

Youth Alternative Services Monthly Update - There are 15 youth with citations. three of the youth are repeat citations. There are 11 students in the Hi-Set Program, 2 students that graduated are enrolling in college. The Youth Alternatives assisted with the T-Town Cancer fund raiser in August, they will also assist with the Suicide Prevention Month and the Airport Fly-In. Ms. Rice will meet with the representative from Worland for the Hi-Set program to go over the program in Hot Springs County. There was discussion about the building Ms. Rice is utilizing and the rent of the building.

Emergency Management Monthly Report – Bill Gordon has trained the new Emergency Management Coordinator for the last 3 weeks, and went over Code Red to make it more efficient. Mr. Gordon's last day was August 31st, but stated he will be checking in to see if Ms. Conrad needs any additional assistance. Ms. Conrad will finish the Threat Hazard Identification and Risk Assessment report to be able to apply for State Homeland Security grants. Ms. Conrad is now familiar with the Wyolink tower. The State is going to be sending 50 emergency kits to the County. Ms. Conrad and Sadie Mounts will do a presentation at the Senior Center over a lunch hour to hand them out. The LAPC meeting will be held on the 13th at 1:30 pm, to go over family emergency plans.

Public Health/Prevention Monthly **Report** – The monthly Public Health Statistics for August was presented which consisted of Child and Adult Immunizations totaling 50, Children's Special Health Clients totaling 3, Long Term Care 101 visits totaling 5, Chronic Disease Clinic visits totaling 24, and other visits totaling 25. Back to School immunization are being completed. The Flu Clinic is being planned for October 12th. The Suicide Prevention walk is planned for September 11th at 6:00 pm.

Planner Monthly Report – The NRPC will meet on September 13th. LUPC met on August 23rd and recommended two minor subdivisions that will be on the Commissioners September 19th Agenda. Planner Bowman went out to the Red Rim Ranch Subdivision to check on the progress and stated the Road and Bridge Supervisor has been checking on it as well. Above ground septic systems may be needed for some Red Rim Ranch houses. Planner Bowman went over the Highland Park plat that is located on the Highway 20 property that was just purchased. This plat needs to be vacated for the projects that are planned there. The Commissioners accepted the Planner's resignation letter. Commissioner Galovich asked if the Planner can assist with the new hire, and start advertising for the position now.

Bailey Enterprises Inc. Liquor Li-<u>cense Renewal</u> – Chairman Ryan opened the Public Hearing for the Bailey Enterprises Inc Liquor License at 10:25 a.m. After three calls for public comment, hearing none, Chairman Ryan declared the hearing closed at 10:29 a.m. Chairman Ryan inquired as to why liquor is not being sold. Mr. Bailey stated they plan to remodel the location dedicated to liquor sales, however it has not happened yet. Mr. Bailey continued stating if the remodel cannot happen soon he can do a temporary construction to sell liquor. The Commissioners approved a 1-year extension, from October 5th, to allow Bailey Enterprises to continue with the remodel, once complete the license can be issued. Commissioner Galovich asked if it is considered non-operational, Clerk Kersten clarified it is non-operational.

Legion Town and Country Club Inc. <u>Liquor License Renewal</u> – Chairman Ryan opened the Public Hearing for Legion Town and Country Club, Inc. Liquor License Renewal at 10:49 a.m. After three calls for oublic comment, hearing none, Chairman Ryan declared the hearing closed at 10:50 a.m. The Commissioners approved renewal of Liquor License for the Legion Town and Country Club, Inc., Thermopolis Golf Course, noting that all fees had been paid.

SonRise Operations LLC Liquor License Renewal – Chairman Ryan opened the Public Hearing for SonRise Operations LLC Liquor License Renewal at 10:50 a.m. After three calls for public comment, hearing none, Chairman Ryan declared the hearing closed at 10:51 a.m. The Commissioners approved Chairman's signature on the renewal of the Liquor License for SonRise Operations LLC, noting all fees had been paid.

The LLL Company Liquor License Renewal – Chairman Ryan opened the Public Hearing for LLL Company Liquor License Renewal at 10:55 a.m. After three calls for public comment, hearing none, Chairman Ryan declared the hearing closed at 10:57 a.m. The Commissioners approved Chairman's signature on the renewal of the Liquor License for the LLL Company, not-

ing all fees had been paid.

<u>Vehicle Trade-In for Sheriff</u> – Sheridan Motors, the company the Sheriff had been working with for the new truck purchase, only offered \$3,000 for a trade in value for the 2014 Ram. Sheriff Kraushaar stated the Kelly Blue Book fair trade in value is \$8,500. Sheriff Kraushaar asked if the Commissioners preferred to advertise or trade-in to Sheridan Motors. The Commissioners agreed to advertise the truck. Commissioner Scheel suggested sealed bids for the truck. Sheriff Kraushaar asked if a minimum bid can be placed on it, such as \$5,500. The funds from this sell would go to the up-fit of the new truck, or back to the General Fund. Sheriff Kraushaar asked the Commissioners if he could donate old, obsolete equipment to other municipalities if they are in need. The Commissioners agreed.

WBC Grant Application Update/RFI Response Summary – There was a meeting with grant writers MC2 and information has been submitted to them. MC2 will get the County a draft of the narrative by September 14th. The Public Hearing was advertised in the September 7th newspaper. Mrs. Guntly is still collecting a few documents. The Request for Information (RFI) report included all envelopes were sealed, submitted on time, and the basic guidelines were met. The ideas included: State-Wide Shooting Complex; Spa Health Facilities, Business Park, Outdoor Recreation, and a

facility to entertain people with a combination of activities; use of the hangar apron for small engine repair shop and bike repair and rentals; and a residential airpark. RFI was done for the WBC grant to see if an RFP should be released.

Procedure for Pre-Payment of Airport Fuel Bills - The Commissioners approved all three signatures on the new Memo and procedure for paying the Av gas and Jet Fuel invoice to CityServiceValcon from the airport fund 30 fuel invoices. County Clerk explained this memo will allow a pre-payment out of the General Fund for up to \$50,000 a month. Commissioner Scheel confirmed the vendor had been contacted to ask for an extension for payment and the vendor will not allow it. Commissioner Galovich and Chairman Ryan asked if \$50,000 was enough, and the motion was amended to state up to \$60,000. Chairman Ryan asked Clerk Kersten to amend the memo and use

their stamps once completed. Other Business – 1) Approval of Facility Use Agreement for Annex Meeting **Room**—The Commissioners approved Chairman's signature on Facility Use Agreement for South Thermopolis Water and Sewer District monthly meetings second Thursday of the month from 6:30 p.m. to 7:30 p.m. 2) Appointment of Weed and Pest Board Mem-<u>ber</u> – The Commissioners appointed Brett Belden to the Weed and Pest Board for area 3. 3) Ratification of MC2 Collaborative Agreement-The Commissioners ratified the MC2 Collaborative agreement for the WBC grant in the amount of \$850.4) Approval of Memorandum of Understanding with HSC Rural <u>Water JPB</u> – The Commissioners approved signature on the Memorandum of Understanding with the Hot Springs County Rural Water Joint Powers Board for the office space and professional services in the amount of \$500. 5) Approval of Agreement for Detention Center Plumbing, Rawhide Mechanical, Inc. in the Amount of \$330,124 – The Commissioners approved Chairman's signature on the agreement with Rawhide Mechanical for the detention center re-plumb in the amount of \$330,124. 6) Approval of RFR#2 Seal Coat and Mark Pavement in the Amount of \$126,644.40 - The Commissioners approved Chairman's signature on RFR#2 Seal Coat and Mark Pavement project (\$111,250.71 WYDOT share; \$12,361.19 County share). 7) Approval of Request for Payment #14 Black Mountain Road in the Amount of \$33,443.41 – The Commissioners approved Chairman's signature on the Request for Payment #14 (\$5,016.51 paid by County; \$28,426.90 paid by WYDOT). Clerk Kersten wanted to let the Commissioners know it was requested and received. 11) Approval of Ardurra Scope of Work and Estimate for <u>THP Airport</u> – Chairman Ryan reported Road and Bridge, Commissioner Galovich, WYDOT, Ardurra and himself met to discuss the right-of-way for the construction of the road on the newly purchased Ingles property. Ardurra will do the preliminary work to construct the road and survey the property. The Commissioners approved the scope of work. 12) Approval of Airport Layout <u>Plan</u> – The Commissioners approved the Hot

ORDINANCE 871

AN ORDINANCE APPROVING CHANG-ING THE DEFINITION OF TOBACCO IN ARTICLE XI SECTION 11-1101(a).

WHEREAS, the original Town Code Section 11-1101(a) requires tobacco leaf to be in the product,

WHEREAS, many modern nicotine products do not contain tobacco leaves yet are designed to provide nicotine like tobacco

WHEREAS, the State of Wyoming changed the definition of Tobacco in the State Statutes

NOW THEREFORE, THE GOVERN-ING BODY OF THE TOWN OF THER-MOPOLIS, HEREBY ORDAINS THE DEFINITION OF TOBACCO TO READ AS FOLLOWS:

"Tobacco Products" means any substance containing nicotine, including, but not limited to cigarettes, cigars, pipe tobacco, snuff, chewing tobacco, dipping tobacco, electronic cigarettes, vaping products and any other nicotine product regulated by the Unites States Food and Drug Administration.
