Approval of Minutes - The Commissioners approved the minutes from June 17, 2025 meeting.

GIS Monthly Update - In June Ms. Ross worked with the Planner's office on the septic permit data model and field maps application, Ms. Ross shared her screen to demonstrate the changes. Ardurra also added Hot Springs County Thumbnails to ArcGIS online layers, maps and applications. In the coming months Ardurra will continue to work with the planner and data for Next-Gen911. Request for Approval of GIS Agreement in the Amount of \$50,000 -Commissioner Galovich inquired about the funds for the agreement. Clerk Kersten explained it will come out of the general fund (Miscellaneous Accounts), which are shared accounts for all departments to use, such as landfill. Commissioner Galovich clarified that the departments did not budget for this agreement separately. Commissioner Galovich stated he is not comfortable with funding this outside agreement with the public here concerned about the budget. Chairman Ryan did not agree with Commissioner Galovich's comment; these services have been important to all the departments. Commissioner Aguiar suggested tabling the GIS agreement until July 8th after the budget hearing.

Fixed Based Operator (FBO) Monthly Report – There were 164 total recorded operations. Fuel sales included 1,443.51 gallons of Avgas and 1,105.7 gallons of Jet Fuel. Mr. Messenger is still mowing and weed eating and made some repairs to one of the pto shaft clutches on the bat wing mower. The Fly-In Event is being planned for September 13th, with the Billings Flying Mustangs model airplanes.

Road and Bridge Monthly Report In the month of June, the Road and Bridge crew finished spring blading, repaired Kirby Creek Road, reset a cattle guard on East Sunnyside Road and removed millings from the old airport

apron for county use. Mr. Rankin stated he spoke with Audra Dominguez regarding the use of the old airport for concert parking, moving has not been completed and the concert is a week and a half away. Mr. Rankin stated the runway and access road cannot be used during the concert, as the contractor is not finished with the work. The Commissioners requested Mr. Rankin return to the Commissioners on July 8th for an update on the old airport use request for concert parking. Black Mountain Road Update - The contractors have been working at the old airport, and are mobilizing at Black Mountain Road. The Wilson Brothers will use top soil from Kirby #2 pit.

<u>Maintenance Monthly Report</u> – The supplies for the courthouse door locks are coming in. CRCI, LLC came to inspect the roofs and provided reports to Mr. Dorman, which he will review and report back regarding actions needed, if any.

<u>Planner/Project Manager Monthly Report</u> – The Report from Engineering Associates for the Red Rim Ranch Subdivision Road Review was provided to the Commissioners. The Commissioners requested to go over the report at the July 8th Commissioners meeting to ensure time for all parties to review. Mr. Culliton inquired if the Commissioners want to comment on the Wyoming Game and Fish permit process for guided fishing regulations; the Commissioners do not see a need to comment. The Big Horn Basin Sage Grouse work group met on May 30th, asked whether the Commissioners wish Mr. Culliton to be a part of that group. Chairman Ryan agreed he be a part of the conversation. Mr. Culliton requested a work session on August 5th for septic system permits. Natural Resource Planning Committee held a meeting on June 11th. Land Use Planning Commission met ln June 25th, a Public Hearing will be held on July 8th for Burrows Land Use Change. <u>Prevention/Public Health</u> – Public Health nurses went to an immunization

training in Casper. Public Health is currently handling the Public Health Emergency Preparedness and Emergency Management grants; Sady Mounts will provide reports to the Commissioners as needed, but report to Shawn Mohr for day to day activities. Prevention Coalition is working on an under-age drinking campaign. The Wyoming Department of Health did a site visit for the Prevention Coalition and congratulated Jennifer Cheney on a successful program.

Youth Alternatives Monthly Update - The Youth Alternatives program is finishing up the Stake Park project with painting and landscaping. The program is also contributing to town cleanup projects, including property clean-up and community gardens. <u>Discussion of Ag Budget</u> - University of Wyoming Extension Program repre-

sentatives, presented the budget issue for the Agricultural department. Chairman Ryan opened the conversation stating the County started this budget season 2.1 million dollars short, outside entities all received a budget cut. Chairman Ryan discussed the letter to the editor written by Matt Helie, which appeared to misrepresent the cuts; the County is not completely eliminating the 4-H program and the County's portion of Dawn Peil's annual compensation is budgeted. Mr. Helie presented some documents in regards to the funding of the 4-H program stating the Admin position is key to connecting the community to resources. Commissioner Galovich inquired if the admin position can be seasonal or part time. Mrs. Peil stated yes it could be an option. Commissioner Aguiar stated he has been to the office in June about 6 times and it was closed with no signs on the doors, and stated the issue is the County does not have the funds this year. Commissioner Galovich stated savings from the GIS agreement may be applied to the local programs. Mr. Stam stated the Admin can be out of the office due to official County business. Comments were received from the public. Sharon Cordingly inquired about the Only Co agreement on the Agenda, the Commissioners stated that agreement is being paid for by a federal grant, not the County budget. Candice Whitt is in support of 4-H stating the timing is not good with fair coming up for the 4-H animals; Chairman Ryan stated the County budget year ends June 30th. Amy Culbreath inquired about the budget short fall. Chairman Ryan stated the oil price dropped, reduction in property tax, general inflation, and COVID funding is gone. Mandy Wilson is in support of 4-H and requested the Commissioners think outside the box, possibly giving up a part of their salary. John Waid is in support of 4-H stating if the kids do not have a positive direction they will get into trouble. Cindy Toth inquired about every department budget cuts. Chairman Ryan stated yes all departments reduced their budgets. Jackie Dorothy is in support of 4-H, and wishes the Commissioners to continue to try to find funds. Sid McDonald is in support of 4-H, and inquired about the funds lost from the Tipi Retreat lawsuit. Billie Jo Norsworthy inquired about the statute for Fair, Clerk Kersten read State Statue 18-9-101. Mariam Erkinbaeva is in support of 4-H and thinks it is good for homeschooled kids. Shane Rankin, Road and Bridge, wanted to inform everyone, the employees of the County took a cut as well not only the department budgets. Larry Bentley stated it appears to him the cuts are directed at agricultural. Mrs. Peil asked about how to move forward, Chairman Ryan stated the proposal needs to be sent to Clerk Kersten. Amy Culbreath inquired about why the County forgave the fines from the Tipi Retreat Lawsuit. Commissioner Galovich stated it was a settlement for the case not to be appealed to the Supreme Court. Shurie Scheel stated the County budget was negatively impacted by property tax cuts passed by the Wyoming Legislator this last session, property

taxes are collected in the County and distributed in the County. <u>Discussion of Fair Budget</u> – Fair Board representatives presented a chart to the Commissioners regarding the Fair budget and changes they will enforce to continue to operate the facility. Budget restructuring includes – tractor payoff, employee restructuring to reduce three positions to one, increasing the user fees, adding membership fees, decreasing maintenance funds, adding a reduced rate for charity and nonprofit events, tear own and set up fees, fair budget cuts, and they hope to increase sponsorships. The only way this budget will work is if people will pay the increased fees. Ms. Norsworthy inquired about emergency or unforeseen maintenance assistance. Chairman Ryan stated the County has a depreciation funds for the fair buildings.

Discussion of Other Budget Items -No further comments were presented regarding other budget items.

Other Business - 1) Reading into Minutes the 2025-26 Proposed Budget Summary - The Commissioners approved to enter the proposed 2025-26 budget into the minutes. Clerk Kersten stated a reconciliation report will be presented for the final budget.

Fraud prevention workshop

A small but lively group joined a fraud prevention workshop at the Hot Springs County Library on July 8th. Tia Gillespie and Kayte Collamer, both from Central Bank & Trust, handed out a wealth of information, as well as snacks and drinks, as people settled in. Patrol Sargeant Casey Freund from the Hot Springs County Sheriff's Office, led the talk. Starting in April, Lisa Brown, who head's up Adult Librarian Services, coordinated with Gillespie and Collamer, to create this event. Freund led the talk and defined

several types of scams, including skimming (credit card information theft), through email, and phone calls (spoofing) as common ways people

may encounter fraud attempts. "It's very easy to download a virus and let it install," Freund said of email links people might receive. The more common phishing scam is through phone calls. Spoofing calls can range from "winning" something to the use of family member names to extort money for a phony emergency. 'Urgency is the thing to watch

out for," Freund says, followed by "If it's too good to be true, it's too good to be true." With a variety of pamphlets, including what to watch out for and who to contact if fraud has been attempted or successful, attendees walked away with great information and a sense of comfort with the knowledge gained from the workshop.

Discovery Days

Discovery Days was created, planned, and executed entirely by volunteers. While Dominguez says it's a lot of work not only during the event but throughout the year in planning, there isn't anything else she would rather be doing. 'We need events like

this," she said, already thinking about planning for next year. "I'm super grateful for our volunteers - we have an amazing team." Volunteer ages range from 30s to 80s, suggesting that everyone in town wants to be part of the community. "The heart in the community that comes together to put this on" is what keeps Dominguez going.

Because of her dedication to Thermopolis, Dominguez started a non-profit to help fund Discovery Days in the


