

## Council concerned with future growth

The Thermopolis Town Council discussed at length a proposal to tie the South Thermopolis Water District to a water line being built by Owl Creek Water District west of town during its May 22 meeting.

The Owl Creek water line connects to a new town water line installed during the town's recent water tank project. The Wyoming Water Development Commission (WWDC) recently proposed a connection with South Thermopolis Water and Sewer District in order to reduce costs involved in the South Thermopolis upgrade and renovation project.

The proposal also would eliminate the town's current connection to the South Thermopolis District along Highway 20 South.

The connection of Owl Creek's line with the South Thermopolis line has the potential to benefit the town, but also there are some drawbacks, said Mayor's Assistant Fred Crosby.

Crosby said the proposed line connecting South Thermopolis could help the town do away with the Cedar Ridge water storage tank, which is an older tank that has had problems in the past and would require major maintenance in the future.

The project could also allow the town to address water pressure issues along 14th Street and near Meadowlark Lane.

For South Thermopolis, the project is beneficial because the district would no longer be required to build a new tank and pump station as part of its upgrade project.

A drawback to the town would be the increased cost of electricity to pump water to the new tanks west of Roundtop, Crosby said. The WWDC has suggested the town address the issue of increased costs when negotiating the contract with South Thermopolis to provide water along the new line.

Town Clerk Tracey Van Heule also reminded the council of the cost of depreciation on the lines if the town takes ownership of them.

Public Works Director Ernie Slagle stated the need to complete maintenance and replacement of a line along 14th Street before the proposal takes effect.

### Town ownership

Crosby stated he had stressed the importance of the town to have ownership of the lines.

Under the proposal, the town

would own the Owl Creek line up to where South Thermopolis connects to the system. The town would then own the line running south until it connects with the rest of the South Thermopolis system.

Owl Creek representative Bart Bader said at the meeting that the Owl Creek district supports the proposal and has no problem turning ownership of the line over to the town.

Heath Overfield, of Engineering Associates, represented the South Thermopolis district in bringing the proposal to the council.

Crosby said prior meetings with the WWDC and both districts indicated the town's decision whether to support the proposal or not may have bearing on future funds allocated to the town from the WWDC for other water projects.

Councilman Tom Linnan motioned to proceed with the proposal because he did not think the town had much choice other than to go along with the WWDC's proposal.

### Annexation

During the discussion, Councilman Dick Hall brought up the issue of annexation with regard to future growth of the town.

Hall reasoned that the town's growth is slowly heading into stagnation because areas likely to be annexed would already have the necessary utilities the town provides within reach of the proposed lines.

Crosby said one of the reasons the town is insisting on ownership of the lines is in order for the town to control the growth that may occur along the lines.

The town has entertained annexation south of the town in the past, along the commercial districts adjacent to Highway 20 South. Annexation was not possible because the town would be taking the majority of the South Thermopolis large water users, and it would not have been feasible for the district to survive without those users.

Overfield said the proposal may benefit the town with future annexations because of the closure of the connection on Highway 20 South and the expansion of the district.

The council passed a motion to start the process to annex portions of land west of Thermopolis between the existing town limits and the proposed water lines.
